

**THE POOLE (TRAFFIC MANAGEMENT)  
(WINSTON AVENUE/SUNRIDGE CLOSE/FARNHAM ROAD) (AMENDMENT NUMBER 190) ORDER 2015**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.12 be amended as follows:

**A. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:**

i	Farnham Road	both sides	from its junction with Winston Avenue	for a distance of 14 metres in a north-westerly direction

i.	Sunridge Close	both sides	from its junction with Winston Avenue	for a distance of 14 metres in a westerly direction
ii	Sunridge Close	south side	from a point 105 metres from its junction with Winston Avenue	for a distance of 30 metres in a north-westerly direction

i	Winston Avenue	west side	from a point 10 metres south of its junction with Winston Avenue	for a distance of 30 metres in a north-westerly direction

**B. The following shall be added to Schedule No. 6.09 (No Loading or Unloading, Mon-Fri, 8am-10am and 2pm-4pm) to the Order:**

i	Farnham Road	both sides	from its junction with Winston Avenue	for a distance of 14 metres in a north-westerly direction

i.	Sunridge Close	both sides	from its junction with Winston Avenue	for a distance of 14 metres in a westerly direction
ii	Sunridge Close	south side	from a point 105 metres from its junction with Winston Avenue	for a distance of 30 metres in a north-westerly direction

i	Winston Avenue	west side	from a point 10 metres south of its junction with Winston Avenue	for a distance of 30 metres in a north-westerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 12 shall remain in full force and effect.
3. This Order shall come into operation on the Sixth Day of October of the Year Two Thousand and Fifteen and may be cited as: The Poole (Traffic Management) (Winston Avenue/Sunridge Close/Farnham Road) (Amendment No. 190) Order 2015.
