

**THE POOLE (TRAFFIC MANAGEMENT)
(POTTERY ROAD/MILL LANE) (AMENDMENT NUMBER 194) ORDER 2015**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.12 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting at Any Time) from the Order:

i	Pottery Road	north-east side	from the common Boundary of Nos. 29 and 31 Pottery Road	for a distance of 44 metres in a south-easterly direction

B. The following shall be deleted from Schedule 5.09 (No Waiting, Mon-Fri, 8am-6pm) from the Order

i.	Pottery Road	south-west side	from a point opposite the common boundary of Nos. 29 and 31 Pottery Road	for a distance of 44 metres in a south-easterly direction

C. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:

i	Pottery Road	north-east side	from the common boundary of Nos. 27 and 29 Pottery Road	for a distance of 65 metres in a south-easterly direction

D. The following shall be added to Schedule No. 5.09 (No Waiting, Mon-Fri, 8am-6pm) to the Order:

i	Pottery Road	south-west side	from a point opposite the common boundary of Nos. 29 and 31 Pottery Road	for a distance of 55 metres in a south-easterly direction

E. The following shall be added to Schedule No. 6.09 (No Loading or Unloading, Mon-Fri, 8am-10am and 2pm-4pm) to the Order:

i	Mill Lane	both sides	from its junction with Pottery Road	for a distance of 33 metres in a northerly direction

i	Pottery Road	north-east side	from the common boundary of Nos. 27 and 29 Pottery Road	for a distance of 65 metres in a south-easterly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 12 shall remain in full force and effect.
3. This Order shall come into operation on the Sixth Day of October of the Year Two Thousand and Fifteen and may be cited as: The Poole (Traffic Management) (Pottery Road/Mill Lane) (Amendment No. 194) Order 2015.
