

**THE POOLE (TRAFFIC MANAGEMENT)  
(HEAVYTREE ROAD) (AMENDMENT NUMBER 235) ORDER 2016**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.13 be amended as follows:

**A. The following shall be deleted from Schedule 5.01 (No Waiting at Any Time) from the Order:**

i	Heavytree Road	north side	from a point 12 metres east of its junction with Ardmore Road	for a distance of 78 metres in a north-easterly direction and into the turning head

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 13 shall remain in full force and effect.
3. This Order shall come into operation on the Twelfth Day of July of the Year Two Thousand and Sixteen and may be cited as: The Poole (Traffic Management) (Heavytree Road) (Amendment No. 235) Order 2016.
