**THE POOLE (TRAFFIC MANAGEMENT) (BODLEY ROAD) (AMENDMENT NO. 85)**  
**ORDER 2018**

The Council of The Borough and County of the Town of Poole, the Highway Authority in exercise of its powers under The Highways Act 1980, The Road Traffic Regulation Act 1984, The Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 and The Traffic Management Act 2004, as amended hereby makes the following Order:

1. The Borough of Poole (Various Roads and Parking Places) (Consolidation of Orders made for the regulation of On-Street and Off-Street Parking Places) Order Number 14 be amended as follows:

**A. The following shall be added to Schedule 5.01 (No waiting at any time) to the Order:**

i	Bodley Road	southern	from a point 62 metres west of its junction with Cliff Drive	for a distance of 27 metres in a westerly direction

**B. The following shall be deleted from Schedule 5.01 (No waiting at any time) from the Order:**

i	Bodley Road	southern	from a point 71 metres west of its junction with Cliff Drive	for a distance of 17 metres in a westerly direction
i	Bodley Road	southern	from a point 49 metres west of its junction with Cliff Drive	for a distance of 8 metres in a westerly direction

**C. The following shall be added to Schedule 7.11 (On Street Parking Place Cars and Motorcycles Only) to the Order:**

i	Bodley Road	southern	from a point 57 metres west of its junction with Cliff Drive	to a point 62 metres west of that junction

**D. The following shall be deleted from Schedule 7.11 (On Street Parking Place Cars and Motorcycles Only) from the Order:**

i	Bodley Road	southern	from a point 57 metres west of its junction with Cliff Drive	to a point 71 metres west of that junction
---	-------------	----------	--	--

2. Save as hereby amended The Borough of Poole (Various Roads and Parking Places) (Consolidation of Orders made for the regulation of On-Street and Off-Street Parking Places) Order Number 14 shall remain in full force and effect.

3. The Order shall come into operation on the Tenth Day of January of the year Two Thousand and Nineteen and may be cited as: THE POOLE (BODLEY ROAD) (AMENDMENT NO. 85) ORDER 2018.
