

**BOROUGH OF POOLE**  
**THE POOLE (TRAFFIC MANAGEMENT) (COURTENAY ROAD) (AMENDMENT NO. 81)**  
**ORDER 2018**

The Council of The Borough and County of the Town of Poole, the Highway Authority in exercise of its powers under The Highways Act 1980, The Road Traffic Regulation Act 1984, The Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 and The Traffic Management Act 2004, as amended hereby makes the following Order:

1. The Borough of Poole (Various Roads and Parking Places) (Consolidation of Orders made for the regulation of On-Street and Off-Street Parking Places) Order Number 14 be amended as follows:

**A. The following shall be added to Schedule 5.01 (No waiting at any time) to the Order:**

i	Courtenay Road	west	from a point 50 metres north-west of its junction with Bournemouth Road	for a distance of 37 metres in a northerly direction

**B. The following shall be added to Schedule 8.19 (On Street Parking Place Waiting limited to two hours Mon-Fri 8am-6pm except permit holders (residents) and season ticket holders) to the Order:**

i	Courtenay Road	west	from a point 86 metres north of its junction with Bournemouth Road	for a distance of 77 metres in a northerly direction
ii	Courtenay Road	east	from a point 15 metres from its junction with Bournemouth Road	for a distance of 148 metres in a northerly direction
iii	Courtenay Road	west	from a point 15 metres north of its junction with Bournemouth Road	for a distance of 34 metres in a northerly direction

**C. The following shall be deleted from Schedule 8.19 (On Street Parking Place Waiting limited to two hours Mon-Fri 8am-6pm except permit holders (residents) and season ticket holders) from the Order:**

i	Courtenay Road	both	from a point 15 metres from its junction with Bournemouth Road	for a distance of 148 metres in a northerly direction

2. Save as hereby amended The Borough of Poole (Various Roads and Parking Places) (Consolidation of Orders made for the regulation of On-Street and Off-Street Parking Places) Order Number 14 shall remain in full force and effect.

3. The Order shall come into operation on the Tenth Day of January of the year Two Thousand and Nineteen and may be cited as: THE POOLE (COURTENAY ROAD) (AMENDMENT NO. 81) ORDER 2018.
