THE POOLE (TRAFFIC MANAGEMENT) (WEST QUAY ROAD) (AMENDMENT NO. 95) ORDER 2018

The Council of The Borough and County of the Town of Poole, the Highway Authority in exercise of its powers under The Highways Act 1980, The Road Traffic Regulation Act 1984, The Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 and The Traffic Management Act 2004, as amended hereby makes the following Order:

1. The Borough of Poole (Various Roads and Parking Places) (Consolidation of Orders made for the regulation of On-Street and Off-Street Parking Places) Order Number 14 be amended as follows:

A. The following shall be added to Schedule 5.01 (No waiting at any time) to the Order:

i	West Quay Road	north-west	from a point 55 metres south-east of its junction with Hunger Hill	for a distance of 56 metres in a south-westerly direction

B. The following shall be added to Schedule 6.01 (No loading or unloading at any time) to the Order:

i	West Quay Road	north-west	from a point 55 metres south-east of its junction with Hunger Hill	for a distance of 56 metres in a south-westerly direction

C. The following shall be deleted from Schedule 7.05 (On Street Parking Place with Charges Maximum Stay Four Hours Mon-Sat 8am-6pm Except Permit Holders (Scratch Card)) from the Order:

i	West Quay Road	north-west	from a point 55 metres south-east of its junction with Hunger Hill	for a distance of 53 metres in a south-westerly direction

2. Save as hereby amended The Borough of Poole (Various Roads and Parking Places) (Consolidation of Orders made for the regulation of On-Street and Off-Street Parking Places) Order Number 14 shall remain in full force and effect.

3. The Order shall come into operation on the Twenty-Second Day of January of the year Two Thousand and Nineteen and may be cited as: THE POOLE (WEST QUAY ROAD) (AMENDMENT NO. 95) ORDER 2018.
