
The Council of the Borough of Bournemouth ("the Council"),

- 1. The Borough of Bournemouth (Parking Regulation Orders)(Consolidation) Order 2004 is hereby varied by;
 - a) The deletion from the Schedules thereto of the items contained in Schedule 1 to this Order;
 - b) The addition to Schedules thereto of the items contained in Schedule 2 to this Order.
- 2. The Borough of Bournemouth (Parking Regulation Orders)(Consolidation) Order 2004 as varied on divers dates and save as expressly varied as aforesaid shall continue in full force and effect.
- 3. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
