(WAITING RESTRICTION AND PERMIT PARKING)
ORDER 2014



Bracknell Forest Borough Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1, 2, 4, 32, 35, 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended and the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART I
CITATION AND INTERPRETATION

Citation

1. This Order shall come into operation on the 20th October 2014 and may be cited as the Bracknell Forest Borough Council (Waiting Restriction and Permit Parking) Order 2014.
2. The Bracknell Forest Borough Council Waiting Restriction and Permit Parking Plans ("the Plans") are incorporated into this Order as Schedule 4.

Interpretation

3. In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-

"authorised officer" means the Director of Environment, Culture and Communities for the Council or any other officer of the Council (to whom the Council has delegated all relevant powers) to be designated by the Council;

"carriageway" means a way constituting or comprised in a highway being a way (other than a cycle track) over which the public have a right of way for the passage

of vehicles;

"Civil Enforcement Officer" means a person authorised by or on behalf of the Council to supervise the parking places and enforce the restrictions imposed by this Order;

"company vehicle" means a permitted vehicle of which a company or other body incorporated under the law of England and Wales is the registered keeper;

"Council" means Bracknell Forest Borough Council;

"delivering" and "collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection;

"disabled person's badge" and "parking disc" have the same meanings as in the Local Authorities' Traffic Orders (Exemption for Disabled Persons) (England) Regulations 2000;

"disabled person's vehicle" means a vehicle lawfully displaying in the relevant position a Disabled Person's Badge, or

"dispensation certificate" means a certificate duly issued on behalf of the Council by an Authorised Officer permitting a specified vehicle to wait in specified circumstances on a length or lengths of roads where the waiting or loading of that vehicle would otherwise be prohibited;

"driver", in relation to a vehicle waiting in a parking place or on a road or length of road, means the person driving the vehicle at the time it was left in that parking place or road or length of road;

"Eligible Resident" means a person whose usual residence is an address listed in Schedule 1 to this Order;

"Eligible Business" means a business with registered premises at an address listed

in Schedule 1 to this Order;

"enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment;

"footway" has the same meaning as in section 329(1) of the Highways Act 1980.

"goods" means goods or burden of any description and includes postal packets of any description;

"issuing authority" means the Council or an agent acting on behalf of the Council

"loading" means the loading or unloading of goods to or from a vehicle;

"no loading hours" means in relation to any no loading road the hours during which loading and unloading is restricted as specified on the Plans;

"no loading road" means any of the sides or lengths of roads specified on the Plans where loading is prohibited provided that the expression "no loading road" shall not include any parking place;

"owner", in relation to a vehicle means the person who is named in the vehicle registration document as the registered keeper of a goods or passenger vehicle or the person who has the use of such a vehicle and who is entitled to use such a vehicle as though he/she were the registered keeper thereof;

"PCSO" means a Police Community Support Officer as designated by the Chief Police Officer;

"penalty charge" and *"reduced penalty charge"* means a charge set by the Council under Section 77 of Part 6 and Schedule 9 of the 2004 Act, which is to be paid to

the Council following the issue of a penalty charge notice (PCN) and within 28 days beginning with the date of issue of the notice, or 14 days in the case of a reduced penalty charge;

"penalty charge notice" means a notice issued by or served by a Civil Enforcement Officer pursuant to the provisions of 'The Civil Enforcement of Parking Contraventions (England) General Regulations 2007;

"permit" means a document issued by or on behalf of the issuing authority;

"permit holder" means a person to whom a parking permit has been issued by issuing authority;

"permitted vehicle" means any motor vehicle whose maximum gross weight (as defined in Regulation 4 of the Traffic Sign Regulations and General Directions 2002) does not exceed 3.5 Tonnes.

"prohibited hours" means in relation to any prohibited road the hours during which waiting or loading is prohibited as specified on the Plans;

"prohibited road" means any of the sides or lengths of roads specified on the Plans where waiting is prohibited provided that the expression "prohibited road" shall not include any parking place;

"relevant position" in respect of a disabled person's badge or dispensation certificate or permit means that the badge or dispensation certificate or permit is exhibited with the front facing forward and is legible on the nearside of the vehicle and immediately behind the windscreen. In respect of a disabled person's parking disc means that the side showing the time is facing forward or outward and immediately behind the windscreen or side window nearest to the kerb. Motorcycles are not required to display permits.

"restricted hours" means in relation to any restricted road the hours during which waiting is restricted as specified on the Plans;

"restricted road" means any of the sides or lengths of roads specified on the Plans where waiting is restricted or specific activities are restricted during the restricted hours provided that the expression "restricted road" shall not include any parking place;

"permit parking area" means an area on a highway designated by this order as a parking place where vehicles may wait if displaying in the relevant position a valid permit issued by the issuing authority;

"telecommunication system" has the same meaning as in the Telecommunications Act 1984;

"the 2002 Regulations" means the Traffic Signs Regulations and General Directions 2002, as amended;

"traffic sign" means a sign of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under the 2002 Regulations;

"vehicle" means a motor vehicle as defined in Section 136(1) of the Act of 1984; and

4. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order;
5. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

PART II

PROHIBITION AND RESTRICTION OF WAITING, LOADING AND STOPPING

Prohibition of Waiting

6. Save as provided in Articles 36, 37, 38, 39, and 40 no person shall, except upon the direction or with the permission of a Civil Enforcement Officer in uniform, Police Constable in uniform or PCSO in uniform, cause or permit any vehicle to wait at any time on any prohibited road as specified on the Plans.

Restriction of Waiting

7. Save as provided in Articles 36, 37, 38, 39, and 40 no person shall, except upon the direction or with the permission of a Civil Enforcement Officer in uniform, Police Constable in uniform or PCSO in uniform, cause or permit any vehicle to wait on any restricted road during the restricted hours as specified on the Plans.

Limited Waiting

8. Save as provided in Articles 36, 37, 38 and 39 no person shall, except upon the direction or with the permission of a Civil Enforcement Officer in uniform, Police Constable in uniform or PCSO in uniform, cause or permit any vehicle to wait on any restricted road in respect of which there is specified on the Plans a period during the restricted hours in which waiting is allowed, for a period longer than specified on the Plans or if a period less than that specified on the Plans as being the period in which the vehicle shall not return has elapsed since a previous period of waiting by the same vehicle on the same side of length of road.

Restriction on Loading and Unloading

9. Save as provided in Articles 36, 37 and 39 no person shall, except upon the direction or with the permission of a Civil Enforcement Officer in uniform, Police Constable in uniform or PCSO in uniform, cause or permit any vehicle to wait for the purpose of enabling goods to be loaded or unloaded from the vehicle on any no loading road during the no loading hours as specified on the Plans.

Prohibition of Double Parking

10. Save as provided in Articles 36 and 37 no person shall, except upon the direction or with the permission of a Civil Enforcement Officer in uniform, Police Constable in uniform or PCSO in uniform, cause or permit any vehicle to park on the carriageway in such a way that no part of the vehicle is within 50 centimetres of the edge of the carriageway.

Prohibition of Parking at Dropped Footways

11. Save as provided in Article 41 no person shall, except upon the direction or with the permission of a Civil Enforcement Officer in uniform, Police Constable in uniform or PCSO in uniform, cause or permit any vehicle to park on the carriageway adjacent to a footway, cycle track or verge where:
- (a) the footway, cycle track or verge has been lowered to meet the level of the carriageway for the purpose of:
 - (i) assisting pedestrians crossing the carriageway,
 - (ii) assisting cyclists entering or leaving the carriageway, or
 - (iii) assisting vehicles entering or leaving the carriageway across the footway, cycle track or verge; or
 - (b) the carriageway has been raised to meet the level of the footway, cycle track or verge for the purpose of:
 - (i) assisting pedestrians crossing the carriageway,
 - (ii) assisting cyclists entering or leaving the carriageway, or
 - (iii) assisting vehicles entering or leaving the carriageway across the footway, cycle track or verge.

PART III

PERMIT PARKING AREAS

Designation of Permit Parking Areas

12. The area of land identified on The Plans as permit parking areas are designated to be used subject to the provisions of this Order as parking areas for permitted

vehicles on such days and during such hours as are specified on The Plans.

Restrictions on Waiting

13. Save as provided in Articles 36, 37, 39, and 40 no person shall, except upon the direction or with the permission of a Civil Enforcement Officer in uniform, Police Constable in uniform or PCSO in uniform, cause or permit any vehicle to wait in a permit parking area during the hours specified on The Plans unless there is displayed on that vehicle in the relevant position a Permit issued by the Council that is valid for that zone in which the vehicle is situated. The absence of a Permit on a Vehicle shall be evidence of the fact that a Permit has not been issued to the Owner or Driver of the Vehicle except in the case of Motor Cycles where details of the Motor Cycle are recorded by the issuing authority which identifies the existence of a valid Permit.

Manner of Waiting

14. A person who causes or permits a permitted vehicle to wait in a permit parking area in accordance with the provisions of this Order shall ensure, so far as is practicable, that the vehicle waits in such a position that it is close to and parallel with the kerb.

Placing of Traffic Signs

15. The Council shall indicate the limits of each permit parking area by appropriate traffic signs in accordance with the 2002 Regulations.

Eligibility for Parking Permits

16. Any Eligible Resident who is the Owner of a Permitted Vehicle or has access to a Company Vehicle or hired Vehicle may apply to the Council for the issue of a Permit ("a Residents Permit") for each such Vehicle in their ownership or control subject to the maximum parking permit allocation per household set out in Schedule 2 to this Order.

17. Any Eligible Business may apply to the Council for the issue of a Permit ("a Business Permit") subject to the maximum parking permit allocation per business set out in Schedule 2 to this Order.
18. Any Eligible Resident or Eligible Business may apply to the Council for the issue of a Permit ("a Visitor Permits") for the leaving in a permit parking area vehicles belonging to or being used by a person or persons visiting the Resident or Business. Issue of Visitor Permits to Eligible Residents is subject to the allocation per household set out in Schedule 2 to this Order. Issue of Visitor Permits to Eligible Businesses is subject to negotiation and agreement with the Council. The decision to issue Visitors Permits to Eligible Businesses is at the discretion of the Council.
19. Any agency, professional practice or organisation which manages local doctors, midwives, district nurses, health visitors and various other essential domiciliary medical or caring personnel may apply for the issue of a Permit ("a Healthcare Professional Permit") for the use of these personnel when visiting households in the roads specified in Schedule 1 to this Order. The decision to issue a Healthcare Professional Permit and whether it will be issued to a Vehicle, to an individual or to an agency, professional practice or organisation is at the discretion of the Council.
20. Any tradesperson or service provider may apply to the Council for the issue of a Permit ("a tradesperson/service provider permit") subject to the maximum parking permit allocation as set out in Schedule 2 to this Order.
21. Any private landlord with a valid landlords tenancy agreement for an address listed in Schedule 1 may apply to the Council for a Permit ("a landlords permit") subject to the maximum parking permit allocation as set out in Schedule 2 to this Order.
22. Any Eligible Resident or Eligible Business may apply to the Council for a Permit ("a Temporary Permit"). A temporary permit may be issued by the Council for the following reasons:
 - (a) New vehicle application or change of vehicle where appropriate proof of vehicle eligibility is not immediately available;

- (b) A change of address where proof of address is not immediately available.

Application for Parking Permits

23. Application for a Permit(s) will be made on a form issued by and obtainable from the Issuing Authority. The form must be completed and returned accompanied by a payment for the charge specified in Schedule 2 of this Order and by such documentary evidence of entitlement in respect of an application for a Permit(s) made to them as the Council may reasonably request to verify any particulars or information given to them.
24. (a) On receipt of a properly completed application and fee where appropriate the Issuing Authority shall issue to the appropriate applicant a Permit(s) provided that the applicant qualifies for the Permit(s) and provided further that the issuing of a Permit under Article 18 and 19 shall be at the discretion of the Council.
- (b) Where Permit(s) are issued to any person upon receipt of a cheque or credit/debit card details and the payment is subsequently dishonoured, the Permit/s shall immediately cease to be valid. The Council will serve notice by recorded delivery on the person to whom the Permit(s) was issued at the address shown by the applicant on the application form or at any other address believed to be the applicant's place of abode, requiring that person to surrender the Parking Permit(s), to the Council within 48 hours of the receipt of the notice.

Validity of Parking Permit

25. A Permit shall cease to be valid at the expiration of the date shown on the Permit or on the date of the surrender or revocation of the permit in accordance with the provisions of this Order, whichever date is the earlier.

Charges for Permits

26. The charges for Permit(s) shall be as specified in Schedule 2 to this Order.

27. The charges for Permit(s) may be amended by the Council giving notice in accordance with Section 46A of the Act of 1984.

Replacement Permits

28. The Council may issue on payment of the appropriate fee as specified in Schedule 2, a replacement Permit to any Permit where:
- (a) the permit holder has a change of vehicle; or
 - (b) the Council is satisfied that the Permit has been lost, stolen, destroyed, damaged or defaced.
29. The provisions of this Order shall apply to a replacement permit as they apply to a Permit, except that the date of issue of a replacement permit shall be deemed to be the date on which the original permit was issued.
30. A replacement Permit shall expire on the date on which the permit which it replaces would have expired.

Surrender of Parking Permits

31. A Permit Holder may surrender a Parking Permit to the Council at any time. The Council will not make any refund for the surrender of Parking Permits.
32. A parking permit holder shall promptly surrender their permit(s) to the Council in any of the following circumstances:
- (a) if the permit holder ceases to be an Eligible Resident; or
 - (b) in the case of a parking permit issued to a business, if the business ceases to be an Eligible Business or if the permit holder ceases to be a duly authorised officer, employee or trustee of a business occupying such premises.

33. A residents parking permit which is surrendered to the Council shall cease to be valid with effect from the date of its surrender.

Revocation of Permit

34. Notwithstanding the provision of Articles 31 and 32 the Council may by notice in writing to the parking permit holder revoke the permit in any of the following circumstances:
- (a) in any of the circumstances in which the residents parking permit holder would be required to surrender the permit under Article 32;
 - (b) if the residents parking permit or visitors permit has been issued in contravention of any of the provisions of this Order or as a result of false or incorrect information having been given to the Council in connection with the application for the permit;
 - (c) on the issue of a replacement permit under Article 28;
 - (d) if the Permit holder has used the permit otherwise than in accordance with the provisions of this Order.
35. The Council will not make any refund for the revocation of Parking Permits.

PART IV

EXEMPTIONS

36. Nothing in Articles 6, 7, 8, 9, 10 and 13 shall render it unlawful to cause or permit any vehicle to wait in any of the roads, lengths of road or on the sides of road specified therein for so long as may be necessary to enable a person to board or alight from the vehicle.
37. Nothing in Articles 6, 7, 8, 9, 10 and 13 shall render it unlawful to cause or permit any vehicle to wait in any of the roads, lengths of road or on the sides of road specified therein for so long as may be necessary to enable:
- (a) the vehicle, if it cannot conveniently be used for such purpose in any other

road, to be used in connection with any of the following operations, namely:-

- (i) building, industrial or demolition operations;
 - (ii) the collection of waste by a local authority;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said lengths or sides of road; and
 - (iv) the laying, erection, alteration or repair in or on land adjacent to the said lengths or sides of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus kept or installed for the purposes of a telecommunications code system or of any telecommunications apparatus lawfully kept installed in any position;
- (b) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
- (c) the vehicle of a universal service provider (as defined in section 4(3) and (4) of the Postal Services Act 2000) to be used for the purpose of delivering and/or collecting mail;
- (d) the vehicle to be used for Fire and Rescue, Ambulance or Police purposes;
- or
- (e) the vehicle to be stationary in any case where the person in control of the vehicle,
- (i) is required by law to stop;
 - (ii) is obliged to stop so as to prevent an accident, or
 - (iii) is prevented from proceeding by circumstances outside his/her control

38. Nothing in Articles 6, 7 and 8 shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc, on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began, to wait in any of the roads, lengths of road or on any of the sides of road identified as prohibited roads or restricted roads on the Plans for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road or on the same side of road

on the same day) PROVIDED THAT no vehicle shall so wait in any length of road at any time when a prohibition of waiting for the purpose of loading or unloading applies to that length of road.

39. Nothing in Articles 6, 7, 8, 9 and 13 shall render it unlawful to cause or permit a vehicle which is displaying in the relevant position a valid dispensation certificate and is waiting in accordance with the terms and conditions of the said certificate to wait in any of the roads or lengths of road identified as prohibited roads, restricted roads, no loading roads or permit parking areas on the Plans.

40. Nothing in Articles 6, 7 and 13 shall prevent any person from causing or permitting a vehicle to wait in any prohibited road or restricted road or permit parking area for as long as may be necessary for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjoining that road if it cannot conveniently wait for any such purpose within the curtilage of those premises or in any other road:

PROVIDED THAT, unless notice is given at least five working days in advance to the Council and a dispensation certificate is obtained, no vehicle shall so wait on any day and during such hours;

- (i) in any part of a restricted road identified in the Plans where loading and unloading is prohibited;
- (ii) in any other part of a prohibited road or restricted road for a period of more than 20 minutes during the restricted hours; or
- (iii) in any part of a prohibited road or restricted road during the restricted hours if a period of less than 1 hour has elapsed since the termination of the last period of waiting (if any) of the vehicle on that length of road.

41. Nothing in Article 11 shall prevent a vehicle being parked adjacent to a lowered kerb outside residential premises by or with the consent, but not consent given by reward, of the occupier of the premises. This exception does not apply if the lowered kerb serves a shared driveway.

Dispensation Certificates

42. The Council may issue a dispensation certificate on receipt of written application with at least five working days notice and may impose terms and conditions as appropriate.
43. A dispensation certificate may be cancelled at any time at the sole discretion of the Council and shall thereupon immediately cease to be valid. Notification of such cancellation shall be sent by post to the holder of the certificate at any address that the Council believes to be that person's address and the certificate shall forthwith be surrendered to the Council.

PART V

CONTRAVENTION OF ORDER

Contravention

44. If a vehicle is left in any road or length of road in contravention of any provision of this Order, a Penalty Charge shall be payable.
45. In the case of a vehicle in respect of which a Penalty Charge is payable A penalty charge notice showing the information required by the 2004 Act may then be issued by a Civil Enforcement Officer in accordance with the requirements of the 2004 Act or any subsequent applicable legislation.

Penalty Charge Notice

46. In the case of a Vehicle in respect of which the Penalty Charge may have been incurred, it shall be the duty of a Civil Enforcement Officer to either hand the Penalty Charge Notice to the driver of the vehicle, post the Penalty Charge Notice to the Owner of the vehicle or attach the Penalty Charge Notice to the vehicle in a conspicuous position. The notice shall include the following particulars:
 - (a) the registration mark of the vehicle or, where the vehicle is being used under a trade licence, the number of the trade plate carried by the vehicle;

- (b) the grounds on which the Civil Enforcement Officer believes that a Penalty Charge is payable in respect of that vehicle;
- (c) the date and time the contravention occurred;
- (d) the date of issue of the Penalty Charge Notice;
- (e) the amount of Penalty Charge required to be paid;
- (f) that if the Penalty Charge is paid before the end of the period of 14 days beginning with the date of the notice, the amount of the Penalty Charge will be reduced by the specified proportion or amount;
- (g) that if the Penalty Charge is not paid before the end of the 28 day period a Notice to Owner may be served by the Council on the person appearing to be the owner of the vehicle; and
- (h) the address to which payment of the Penalty Charge must be sent.

Manner of payment of Penalty Charge

47. The Penalty Charge shall be paid to the Council within 28 days of the issue of the penalty charge notice either;

- (a) by cheque, bankers' draft, money order or postal order delivered or sent by post as indicated on the penalty charge notice, or
- (b) by cheque, postal order, in cash by credit card or debit card in person at any Bracknell Forest Borough Council office which accepts such payments, or
- (c) by credit card or debit card over the phone using the number specified on the Penalty Charge Notice, or
- (d) by internet using the Bracknell Forest Borough Council web site:

Provided that, if the said twenty eighth day falls upon a day on which the said Department or office is closed, the period within which payment of the said charge shall be made to the Council shall be extended until 4.30pm on the next full day on which the said Department is open.

48. If the Penalty Charge is paid before the end of the period of 14 days beginning with the date of the notice, the amount of the Penalty Charge will be reduced by the specified proportion.

49. If the owner fails to pay the Penalty Charge by the end of the 28 day period, a Notice to Owner may be served; and if the charge is not paid within a further 28 days it may be increased by 50% on the issue of a Charge Certificate in accordance with the provisions of the 2004 Act.
50. Continuing failure to pay the Penalty Charge may result in a judgement in the County Court against the owner to enable the Council to recover the payments due.

Indications as Evidence

51. The particulars given in the Penalty Charge Notice in accordance with Article 46 shall be treated as evidence in any proceedings relating to failure to pay such Penalty Charge.

Restriction on Removal of Notices

52. Where a Penalty Charge Notice has been issued in accordance with the provisions of Article 46 of this Order, no person, not being the driver of the vehicle, a Civil Enforcement Officer in uniform, Police Officer in uniform or PCSO in uniform or some other person duly authorised by the Council, shall remove the notice from the vehicle unless authorised to do so by the driver.




53. The restrictions as set out in Schedule 3 to this Order are hereby revoked from the following Order:

Bracknell Forest Borough Council (Control of On-Street Parking) (No.2) Order 2013.

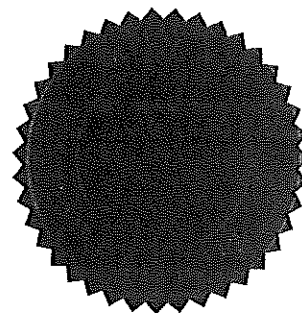

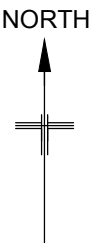

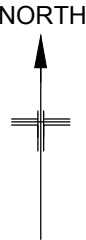
