VARIOUS LOCATIONS WITHIN THE BRADFORD METROPOLITAN DISTRICT

The City of Bradford Metropolitan District Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 32 and 35 of the Road Traffic Regulation Act 1984 hereinafter referred to as “the Act of 1984” and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and Part 6 of the Traffic Management Act 2004 “the Act of 2004” and with those persons and organisations specified in the Local Authorities’ Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:

1. In this Order, the expression “enactment” means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme, or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the City of Bradford Metropolitan District Council (Off Street Parking Places) (Consolidation) (Amendment No. 4) Order 2024 hereinafter referred to as “the Consolidation Order” shall have effect as though:
 - (a) There were substituted in the Second Schedule:
 - (i) the items numbered 39 and 35 set out in the Second Schedule to this Order and shown on Map No. 24 and 28.
3. Designation of Restrictions and application of the Consolidation Order
 - (a) The provisions of the Consolidation Order shall apply to any area designated as an off street parking place by this Order, as if in those provisions any reference to an off street parking place included a reference to an area designated as an off street parking place by this Order and as if any reference to the Schedule to the Consolidation Order included a reference to the Schedule to this Order.
4. Nothing in Article 2 of this Order shall apply to:
 - (a) anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer;
 - (b) any vehicle being used for ambulance, fire brigade or police purposes in an emergency;
 - (c) any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to Section 66 or 67 of the Road Traffic Regulation Act 1984.

5. This Order is made on the 22nd day of August 2024 and shall come into force on the 22nd day of August 2024 and may be cited as the City of Bradford Metropolitan District Council (Off Street Parking Places) (Consolidation) (Amendment No.4) Order 2024 (Part B).

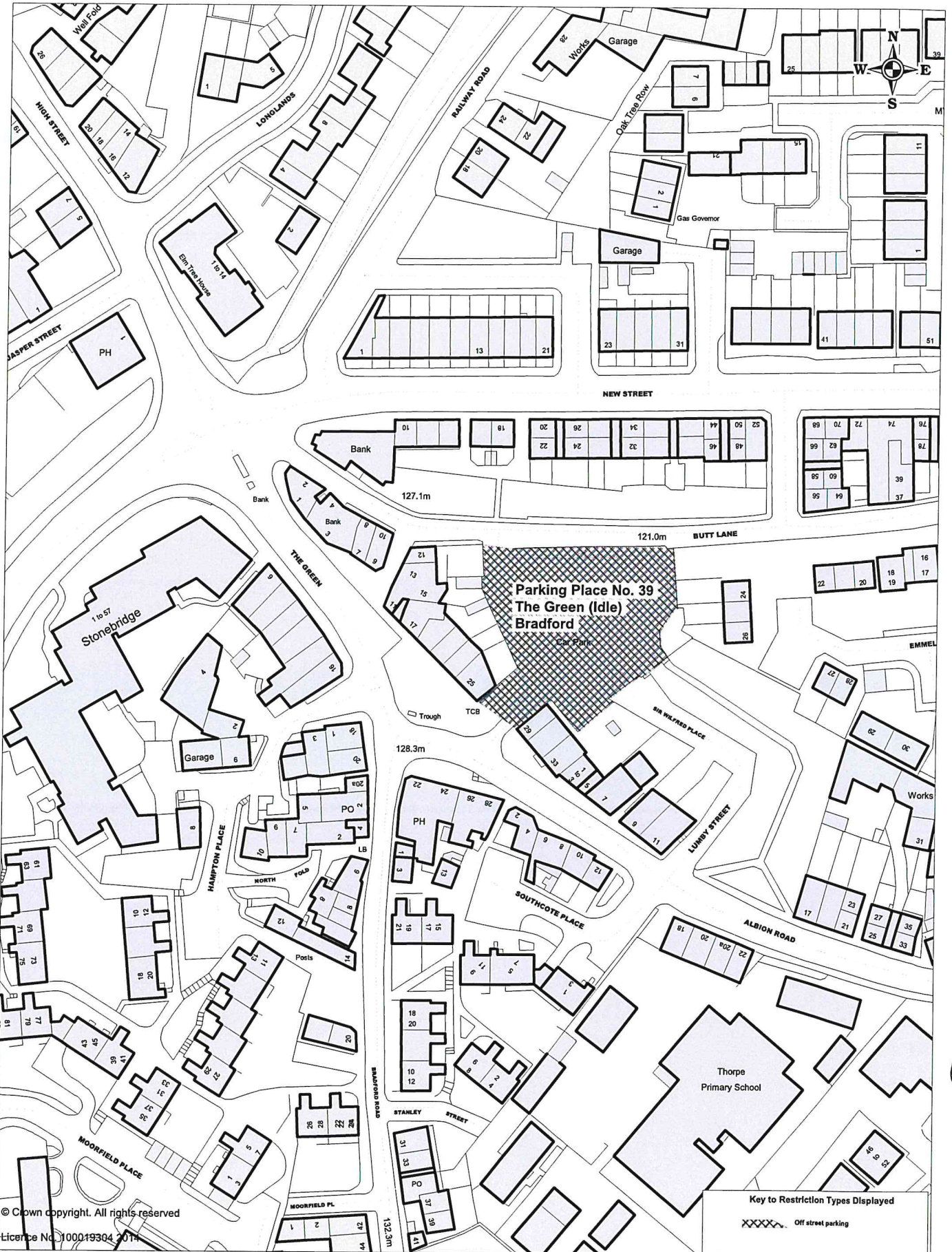
