



**THE ESSEX COUNTY COUNCIL (BRENTWOOD BOROUGH) (PROHIBITION OF WAITING, LOADING AND STOPPING) AND (ON STREET PARKING PLACES) (CIVIL ENFORCEMENT AREA) (AMENDMENT NO. 15) ORDER 2022**

**NOTICE IS HEREBY GIVEN** that Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an agreement dated 31 March 2011 (and subsequently varied by Deed of Variation on 15 June 2011 and 27 July 2012) has made the above Order under Sections 1(1), 2 (1) to (3), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984.

**Effect of the Order:**

All measurements are taken as accurately as possible and are taken from the extended kerb line unless stated otherwise.

**1. In addition to the existing ‘No Waiting Monday to Friday 10am-11am & 2pm-3pm’ restriction introduce Saturday 10am-11am & 2pm-3pm’ on the following lengths of roads in the Borough of Brentwood:**

<b>Shorter Avenue, Shenfield</b>	<b>Both sides</b> – from a point 29 metres southeast of its junction with Chelmsford Road south-eastwards to a point 10 metres northwest of its junction with Margaret Avenue. <b>Southwest side</b> – from a point 13 metres southeast of its junction with Margaret Avenue south-eastwards to a point 33 metres northwest of its junction with Hutton Road. <b>Northeast side</b> – from a point 13 metres southeast of its junction with Margaret Avenue south-eastwards to a point 29 metres northwest of its junction with Hutton Road.
<b>Crossways, Shenfield</b>	<b>Both sides</b> – from a point 25 metres southeast of its junction with Chelmsford Road south-eastwards to a point 14 metres northwest of its junction with Kilworth Avenue.
<b>Hunter Avenue, Shenfield</b>	<b>Northwest side</b> – from a point 18 metres southwest of its junction with Oliver Road south-westwards to a point in line with the property boundary of Nos.50 & 52 Hunter Avenue. <b>Southeast side</b> – from a point 19 metres southwest of its junction with Oliver Road south-westwards to a point in line with the property boundary of Nos.71 & 73 Hunter Avenue.
<b>Sebastian Avenue, Shenfield</b>	<b>Both sides</b> – from a point 15 metres southwest of its junction with Oliver Road south-westwards to a point 15 metres northeast of its junction with Crossways.
<b>Kilworth Avenue, Shenfield</b>	<b>Both sides</b> – from a point 15 metres southwest of its junction with Oliver Road south-westwards to a point 10 metres northeast of its junction with Rochford Avenue. <b>Both sides</b> – from a point 10 metres southwest of its junction with Rochford Avenue south-westwards to a point 10 metres northeast of its junction with Holmwood Avenue. <b>Both sides</b> – from a point 10 metres southwest of its junction with Holmwood Avenue south-westwards to a point 10 metres northeast of its junction with Alwyne Avenue. <b>Both sides</b> - from a point 10 metres southwest of its junction with Alwyne Avenue south-westwards to a point 25 metres northeast of its junction with Crossways.
<b>Alwyne Avenue, Shenfield</b>	<b>Both sides</b> – from a point 15 metres southeast of its junction with Chelmsford Road south-eastwards to a point 10 metres northwest of its junction with Kilworth Avenue.

**2. In addition to the existing ‘No Waiting Monday to Friday 10am-11am & 2pm-4pm’ restriction introduce Saturday 10am-11am & 2pm-3pm’ on the following lengths of road in the Borough of Brentwood:**

<b>Margaret Avenue, Shenfield</b>	<b>Both sides</b> – from a point 15 metres southwest of its junction with Crossways south-westwards to a point 15 metres northeast of its junction with Shorter Avenue.

**Date of operation:** This Order will come into operation on **9 May 2022**.

**Application to the High Court:** Anyone who wishes to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act, or any instrument made under it, has not been complied with in relation to the Order, may within six weeks from the making of the Order apply to the High Court for this purpose.

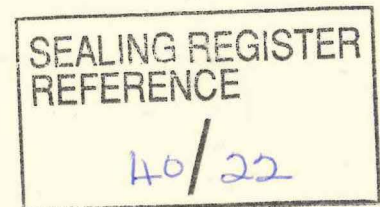




1. The Amendment Order shall come into operation on the 9<sup>th</sup> day of May 2022 and may be cited as The Essex County Council (Brentwood Borough) (Prohibition of Waiting, Loading and Stopping) and (On-street parking places) (Civil Enforcement Area) (Amendment No.15) Order 2022.
