



**THE ESSEX COUNTY COUNCIL (BRENTWOOD BOROUGH) (PROHIBITION OF WAITING, LOADING AND STOPPING) AND (ON STREET PARKING PLACES) (CIVIL ENFORCEMENT AREA) (AMENDMENT NO. 8) ORDER 2021**

**NOTICE IS HEREBY GIVEN** that Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an agreement dated 31 March 2011 (and subsequently varied by Deed of Variation on 15 June 2011 and 27 July 2012) proposes to make the above Order under Sections 1(1), 2 (1) to (3), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984.

**Effect of the Order:**

All measurements are taken as accurately as possible and are taken from the extended kerb line unless stated otherwise.

**1. To revoke 'No Waiting 7pm-7am' on the following length of road in the Borough of Brentwood:**

<b>Chelmsford Road, Shenfield</b>	<b>Northwest side</b> – from a point 35 metres southwest of its junction with Shorter Avenue north-eastwards to its junction with Tudor Close.

**2. To introduce 'No Waiting at Any Time' on the following lengths of road in the Borough of Brentwood:**

<b>Chelmsford Road, Shenfield</b>	<b>Northwest side</b> – from a point 35 metres southwest of its junction with Shorter Avenue north-eastwards to a point 182 metres northeast of its junction with Alexander Lane, not including the access road for No's.110a to 120. <b>Southeast side</b> – from its junction with Tudor Close north-eastwards to a point 65 metres southwest of its junction with Oliver Road. <b>Southeast side</b> – from its junction with Oliver Road north-eastwards to a point 182 metres northeast of its junction with Alexander Lane.
<b>Alexander Lane, Shenfield</b>	<b>Both sides</b> – from its junction with Chelmsford Road south-eastwards for 10 metres.

**3. To introduce 'No Stopping except Buses' on the following length of road in the Borough of Brentwood:**

<b>Chelmsford Road, Shenfield</b>	<b>Southeast side</b> – from its junction with Oliver Road south-westwards for 25 metres.

**4. To revoke 'No Waiting Mon-Fri 10am-11am' and introduce 'No Waiting at Any Time' on the following lengths of roads in the Borough of Brentwood:**

<b>Oliver Road, Shenfield</b>	<b>Northeast side</b> – from its junction with Chelmsford Road south-eastwards for 12 metres. <b>Southwest side</b> – from its junction with Chelmsford Road south-eastwards for 60 metres. <b>Southwest side</b> – from a point 10 metres northwest of its junction with St Mary's Avenue south-eastwards for 26 metres. <b>Northeast side</b> – from a point 2.5 metres northwest of its junction with St Mary's Avenue south-eastwards for 10 metres. <b>Both sides</b> – from its junction with Kilworth Avenue north-westwards for 10 metres.
<b>St Mary's Avenue, Shenfield</b>	<b>Both sides</b> – from its junction with Oliver Road south-westwards for 15 metres. <b>Both sides</b> – from its junction with Rochford Avenue north-eastwards for 15 metres.
<b>Chelmsford Road, access road No's.87-129, Shenfield</b>	<b>Both sides</b> – from its junction with Holmwood Avenue north-eastwards for 15 metres. <b>Both sides</b> – from a point 10 metres southwest of its junction with Rochford Avenue north-eastwards for 26 metres. <b>Both sides</b> – from its junction with Oliver Road south-westwards for 15 metres.

<b>Rochford Avenue, Shenfield</b>	<p><b>Both sides</b> from its junction with Chelmsford Road, access road No's.87-129, south-eastwards for 10 metres.</p> <p><b>Both sides</b> – from a point 10 metres northwest of its junction with St Mary's Avenue south-eastwards for 27 metres.</p> <p><b>Both sides</b> – from its junction with Kilworth Avenue north-westwards for 10 metres.</p>

**5. To revoke 'No Waiting Mon-Fri 10am-11am & 2pm-3pm' and introduce 'No Waiting at Any Time' on the following lengths of roads in the Borough of Brentwood:**

<b>Shorter Avenue, Shenfield</b>	<b>Both sides</b> – from a point 10 metres northwest of its junction with Margaret Avenue south-eastwards for 29 metres.
<b>Crossways, Shenfield</b>	<b>Both sides</b> – from its junction with Chelmsford Road south-eastwards for 25 metres.
<b>Kilworth Avenue, Shenfield</b>	<p><b>Both sides</b> – from a point 10 metres southwest of its junction with Alwyne Avenue north-eastwards for 26 metres.</p> <p><b>Both sides</b> – from a point 10 metres southwest of its junction with Holmwood Avenue north-eastwards for 26 metres.</p> <p><b>Both sides</b> – from a point 10 metres southwest of its junction with Rochford Avenue north-eastwards for 26 metres.</p> <p><b>Both sides</b> – from its junction with Oliver Road south-westwards for 15 metres.</p>
<b>Alwyne Avenue, Shenfield</b>	<p><b>Both sides</b> – from its junction with Chelmsford Road south-eastwards for 15 metres.</p> <p><b>Both sides</b> – from its junction with Kilworth Avenue north-westwards for 10 metres.</p>
<b>Holmwood Avenue, Shenfield</b>	<p><b>Both sides</b> – from its junction with Chelmsford Road south-eastwards for 31 metres.</p> <p><b>Both sides</b> – from its junction with Kilworth Avenue north-westwards for 10 metres.</p>
<b>Oliver Road, Shenfield</b>	<p><b>Both sides</b> – from its junction with Kilworth Avenue south-eastwards for 10 metres.</p> <p><b>Both sides</b> – from a point 10 metres northwest of its junction with Sebastian Avenue south-eastwards for 26 metres.</p>
<b>Sebastian Avenue, Shenfield</b>	<b>Both sides</b> – from its junction with Oliver Road south-westwards for 15 metres.

**6. To revoke 'No Waiting Mon-Fri 10am-11am & 2pm-4pm' and introduce 'No Waiting at Any Time' on the following length of road in the Borough of Brentwood:**

<b>Margaret Avenue, Shenfield</b>	<b>Both sides</b> – from its junction with Shorter Avenue north-eastwards for 15 metres.

**7. To revoke 'No Waiting Mon-Fri 9am- 5pm' and introduce 'No Waiting at Any Time' on the following length of road in the Borough of Brentwood:**

<b>Mount Crescent, Warley</b>	<b>Both sides</b> – from a point 15 metres west of its junction with Hartwood Road westwards for 15 metres.

**8. To revoke 'No Waiting Mon-Fri 11am-Noon' on the following lengths of roads in the Borough of Brentwood:**

<b>Station Road, West Horndon</b>	<b>North side</b> – from a point 10 metres west of its junction with Clavering Gardens eastwards for 50 metres.
<b>Clavering Gardens, West Horndon</b>	<b>East side</b> – from its junction with Station Road southwards for 10 metres.

**9. To revoke 'No Waiting Mon-Fri 2pm-3pm' on the following lengths of roads in the Borough of Brentwood:**

<b>Station Road, West Horndon</b>	<b>South side</b> – from a point 10 metres west of its junction with Clavering Gardens eastwards for 50 metres.
<b>Clavering Gardens, West Horndon</b>	<b>West side</b> – from its junction with Station Road southwards for 10 metres.

**10. To introduce 'No Waiting at Any Time' on the following lengths of roads in the Borough of Brentwood:**

<b>Station Road, West Horndon</b>	<b>Both sides</b> – from a point 10 metres west of its junction with Clavering Gardens eastwards for 112 metres.
<b>Clavering Gardens, West Horndon</b>	<b>Both sides</b> – from its junction with Station Road southwards for 10 metres.

**11. To revoke 'No Waiting at Any Time' on the following length of road in the Borough of Brentwood:**

<b>Warley Hill, Warley</b>	<b>Southeast side</b> – from a point 42 metres northeast of its junction with The Drive north-eastwards for 1.5 metres.

**12. To introduce 'Limited Waiting 2 Hours No Return 4 Hours 8am-8pm' on the following length of road in the Borough of Brentwood:**

<b>Warley Hill, Warley</b>	<b>Southeast side</b> – from a point 29 metres northeast of its junction with The Drive north-eastwards for 10 metres.

**Date of operation:** This Order will come into operation on **12 July 2021**.

**Application to the High Court:** Anyone who wishes to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act, or any instrument made under it, has not been complied with in relation to the Order, may within six weeks from the making of the Order apply to the High Court for this purpose.
