Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment No.4 2017

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment Order No. 4 2017 and shall come into operation on the *14th* day of *August* 2017.
2. Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 is amended as follows:

Delete the following:-

Ref No.	Road Name	Side	Description
329a	Carden Avenue	South	From the junction of London Road eastwards for a distance of 97 metres
478	County Oak Avenue	North east	From the southern kerbline of Carden Avenue south eastwards for a distance of 200 metres

Add following items:-

Ref No.	Road Name	Side	Description
329a	Carden Avenue	South	From its junction with London Road eastwards and northwards to a point opposite the western kerbline of Overhill Gardens
355a	Carden Hill	East	From the southern kerbline of Rotherfield Crescent southwards for 11 metres
478	County Oak Avenue	North east	From the southern kerbline of Carden Avenue eastwards for a distance of 210 metres
558a	Dale Drive	Both	At its eastern junction with Carden Avenue – from the northern kerbline of Carden Avenue southwards for 10 metres.
744a	Eastfield Crescent	East, South and West	From its eastern kerbline of the western junction with Woodbourne Avenue, southwards, eastwards and then northwards to its eastern junction with Woodbourne Avenue (covering that part of the road which fronts 1-11 (odds) Eastfield Crescent.
3248a	Wilmington	East	On Island between Wilmington Parade, Wilmington

	Way	and South	Way and Carden Avenue- from the northern kerbline of its junction with Carden Avenue, southwards to its southern kerbline with its junction with Carden Avenue.
