Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment No.8 2017

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment Order No. 8 2017 and shall come into operation on the 2nd day of October 2017.
2. The Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 is amended as follows:

SCHEDULE 1 AMENDMENTS:

Part 1.1 No Waiting At Any Time

Delete the following items:

494	Craven Road	Both	From its northern junction with Queensway south eastwards for a distance of 9.1 metres
495	Craven Road	Both	From its southern junction with Queensway south eastwards for a distance of 9.1 metres
496	Craven Road	West	From a point in line with the eastern kerbline of Queensway in an anti-clockwise and northerly direction for 414 metres to a point in line with the eastern kerbline of Queensway
497	Craven Road	South-East	From the eastern kerbline of Parham Close north-eastwards for 5 metres.
497a	Craven Road	East	From a point 164 metres eastwards and northwards from the eastern kerbline of Queensway (at its southern junction with Craven Road) northwards for 2 metres.
497b	Craven Road	East	From a point 196 metres eastwards and northwards from the eastern kerbline of Queensway (at its southern junction with Craven Road) northwards for 2 metres.
497c	Craven Road	East	From a point 228 metres eastwards and northwards from the eastern kerbline of Queensway (t its southern junction with Craven Road) northwards for 2 metres.

497d	Craven Road	East	From a point 261 metres eastwards and northwards from the eastern kerbline of Queensway (at its southern junction with Craven Road) northwards for 2 metres
497e	Craven Road	East	From a point 288 metres eastwards and northwards from the eastern kerbline of Queensway (at its southern junction with Craven Road) northwards for 2 metres
497f	Craven Road	North	From a point 316.5 metres eastwards and northwards from the eastern kerbline of Queensway (at its southern junction with Craven Road) northwards for 2 metres
497g	Craven Road	North	From a point 343.5 metres eastwards and northwards from the eastern kerbline of Queensway (at its southern junction with Craven Road) northwards for 2 metres
497h	Craven Road	North	From a point 368 metres eastwards and northwards from the eastern kerbline of Queensway (at its southern junction with Craven Road) northwards for 2 metres.
1148	Hadlow Close	Both	From the western kerbline of Queensway eastwards for a distance of 9.1 metres
2948	Tilgate	Both	From its junction with Queensway south-eastwards for a distance of 9.1m
2948a	Tilgate Close	turning area	From a point 109 metres east of the eastern kerbline of Queensway south, east and northwards for 27 metres to cover the turning area.

Delete the following items:-


154	Craven Road	East	From a point 18 metres north east of the eastern kerbline of Parham Close northwards for a distance of 5 metres(outside No.76)
155	Craven Road	East	From the southern kerbline of the steps between Nos. 116 & 118 Craven Road southwards for a distance of 5.5 metres (outside No.116)
156	Craven Road	East	From a point 117.5 metres north of the eastern kerbline of Parham Close northwards for a distance of 5.5 metres (outside Nos.102/104)
157	Craven Road	North	From the western property wall of No138 Craven Road westwards for a distance of 5.5 metres (outside No.138)
593	Queensway	West	From a point 5 metres north of the prolongation of the northern kerbline of the north arm of Craven Road northwards for a distance of 5 metres (outside Flats 89-91)

595a	Queensway	West	From a point 18 metres north of the northern kerbline of Southwater Close northwards for a distance of 6.6 metres (outside No.31)
