

## BRIGHTON & HOVE CITY COUNCIL

### Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment No.12 2017

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 63 and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment Order No.12 2017 and shall come into operation on the 13<sup>th</sup> day of November 2017.
2. Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 is amended as follows:

#### **SCHEDULE 1 AMENDMENTS:**

##### **Part 1.1 No Waiting at Any Time**

**Delete the following:-**

Item No.	Road Name	Side	Description
484a	Court Ord Road	Both	From its junction with Falmer Road westwards for 6 metres.
2419	Roedean Road	Both	From the northern kerbline of Marine Drive north-westwards for 100 metres.

**Add replace with item:-**

Item No.	Road Name	Side	Description
484a	Court Ord Road	Both	From its junction with Falmer Road westwards for 9 metres.

**Add in the following new items:-**

Item No.	Road Name	Side	Description
587a	Dean Court Road	South	From a point 3.5 metres east of the western property boundary wall of no.2 westwards for 14 metres.
2419	Roedean Road	North	From the northern kerbline of Marine Drive north-westwards for 100 metres.
2419a	Roedean Road	South	From the northern kerbline of Marine Drive northwards and then westwards for a distance of 316 metres.

2420a	Roedean Way	East	From the southern kerbline of Roedean Road northwards for a distance of 7 metres.
2420b	Roedean Way	West	From the southern kerbline of Roedean Road northwards for a distance of 9.5 metres.
2489a	St Aubyns Mead	South	From the western property boundary of Kipling Court for 28 metres.
