Brighton & Hove Various Controlled Parking Zones Consolidation Order 2015 Amendment Order No.23 2017

Brighton & Hove City Council ("the Council") in exercise of its powers under sections 1(1), 2(1) to (3), 3 (2), 4, 32, 35, 45, 46, 49, 53, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.
