Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment Order No.13 2017

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4, 53 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment Order No.13 2017 and shall come into operation on the 8th day of January 2017.
2. Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 is amended as follows:

Add New items:-

Ref No.	Road Name	Side	Description
16	Lewes Road	West	From the northern kerbline of Union Road northwards to a point 74 metres south of the southern kerbline of Trinity Street
17	Lewes Road	East	From the northern kerbline of Elm Grove northwards for a distance of 73 metres

Part 2.10 No Loading/Unloading Monday to Saturday 7am to 10am and 4pm to 7pm

Delete the following item:-

Ref No.	Road Name	Side	Description
1	Lewes Road	West	From the northern kerbline of Union Road northwards to the southern kerbline of Park Crescent
2	Lewes Road	West	From the northern kerbline of Park Crescent Place northwards to the southern kerbline of Trinity Street

Replace with the following:-

Ref No.	Road Name	Side	Description
1	Lewes Road	West	From the southern kerbline of Trinity Street southwards for 14 metres
2	Lewes Road	West	From a point 55m south of the southern kerbline of Trinity Street southwards for 19 metres.



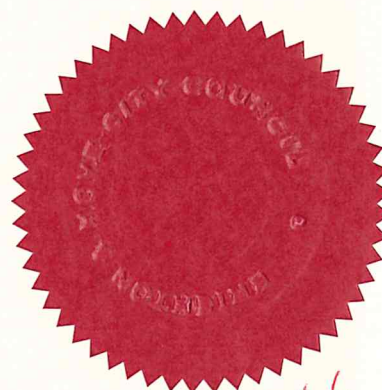
