### Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment No.5 2018

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4 and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment Order No.5 2018 and shall come into operation on the 7<sup>th</sup> day of May 2018.
2. The Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 is amended as follows:

#### SCHEDULE 1 AMENDMENTS:

##### Part 1.1 No Waiting At Any Time

Add new items:-

785a	Elizabeth Avenue	West	From the northern kerbline of Mill Drive northwards for a distance of 7 metres
785b	Elizabeth Avenue	West	From the southern kerbline of Mill Drive southwards for a distance of 10 metres
1089a	Goldstone Crescent	North	From the boundary between Nos.171 &173 Goldstone Crescent westwards to the boundary between Nos.179-181 Goldstone Crescent
1882a	Mill Drive	North	From the western kerbline of Elizabeth Avenue westwards for a distance of 7 metres
1882b	Mill Drive	South	From the western kerbline of Elizabeth Avenue westwards for a distance of 6 metres
3309a	Woodland Avenue	South	From a point 21.5 metres west of the western kerbline of Woodland Avenue westwards then southwards for a distance of 18 metres

Delete the following:-

Item No.	Road Name	Side	Description
1074	Goldstone Crescent	North east	From the north western kerbline of Woodland Drive north west for 20 metres
1079	Goldstone Crescent	North	From the eastern kerbline of Woodland Avenue east for 15 metres and from the western kerbline of Woodland Avenue west for 15 metres
3307	Woodland Avenue	Both	From the northern kerbline of Goldstone Crescent north for 15 metres

Replace with the following:-

1074	Goldstone Crescent	North east	From the north western kerbline of Woodland Drive north westwards for 36 metres
1079	Goldstone Crescent	North	From the western kerbline of Woodland Avenue west for 15 metres
1079a	Goldstone Crescent	North	From the eastern kerbline of Woodland Avenue eastwards for 52 metres
3307	Woodland Avenue	West	From the northern kerbline of Goldstone Crescent northwards for 15 metres
3307a	Woodland Avenue	East	From the northern kerbline of Goldstone Crescent northwards 31 metres
