## **BRIGHTON & HOVE (BUS LANES) CONSOLIDATION ORDER 2018**

Brighton & Hove City Council in exercise of its powers under Sections 1 (1), 2(1) to (3), 4 (1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act ("the Act") as amended and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby makes the above named Order.

#### **PART 1 - GENERAL**

- 1. This Order shall come into operation on the 15<sup>th</sup> of October 2018 and may be cited as the "Brighton & Hove (Bus Lanes) Consolidation Order 2018"
- 2. (1) This Order is made for the purpose of a general scheme of control of the bus lanes in the roads identified in Schedule 1 and Schedule 2 to this Order.
  - (2) This Order consolidates in whole or in part the Orders listed in Schedule 3
- 3. In this Order, except where the context otherwise requires, the following expressions have the meanings assigned to them:-
  - "Authorised Person" means an employee or agent of the Council authorised to exercise all or any of the functions of the Council under this Order;
  - "Bus" has the same meaning as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016
  - "Bus lane" means an area of road that may be used only by buses (or a
    particular description of bus) and some other class or classes of vehicular
    traffic as provided for in this order;
  - "Bus gate" has the same meaning as bus lane;

- "Bus-only route" means a traffic lane that may be used only by buses;
- "Contravention" means a failure to comply with restrictions set out in this Order that may result in the issue of a penalty charge notice;
- "Contra-flow", "with-flow" and "traffic lane" have the same meanings as in Schedule 1 of The Traffic Signs regulations and General Directions 2016";
- "Emergency services vehicle" means a vehicle operated by the police, fire & rescue service or ambulance service;
- "Pedal cycle" has the same meaning as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;
- "Powered two-wheeler" means a mechanically propelled vehicle with two wheels without trailer or sidecar;
- "Private hire vehicle" has the same meaning as in Section 80 of the Local Government (Miscellaneous Provisions) Act 1976;
- "Road marking" means a traffic sign consisting of a line or mark or legend on the surface on the road of a size, colour and type prescribed or authorised under Section 64 of the Road Traffic Regulation Act 1984;
- "Security vehicle" means a vehicle specially adapted to securely convey cash, bullion or valuables and marked with the name of the security company;
- "Taxi" has the same meaning as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;
- "Traffic Signs Regulation and General Directions" means the Traffic Signs Regulation and General Directions 2016 as amended from time to time;
- "Traffic Sign" means a sign of a size, colour and type prescribed or authorised under, or having an effect as though prescribed or authorised under Section 64 of the Road Traffic Regulation Act 1984;
- "Undertaker" has the same meaning as in the meaning ascribed to it in section 48 of the New Roads and Streetworks Act 1991;
- "Universal postal service provider" shall have the meaning ascribed to it in section 4 (1) of the Postal Services Act 2000;
- "Vehicle" means a mechanically propelled or pedal powered form of transportation intended or adapted for use on the road;

- 4. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated or reenacted by or as having effect by virtue of any subsequent enactment.
- 5. In so far as any provision of this Order conflicts with a provision which is contained in an Order made or having effect as if made under the Act, and existing when this Order comes into operation, and which imposes a restriction or prohibition on movement by vehicles or grants an exemption from such restriction or prohibition, the provisions of this Order shall prevail.

#### PART 2 – BUS LANE TRAFFIC RESTRICTIONS

- 1. Subject to the provisions of Article 1 of Part 3 no person shall cause a vehicle to be in the lengths of road specified in column (2) Schedule 1 to this Order, during the hours specified in that part, unless that vehicle is proceeding in the direction specified in column (4) of that item and is of a type specified in column (5) of that item.
- 2. Subject to the provisions of Article 1 of Part 3 no person shall cause a vehicle to be in a length of road specified in an item in column (2) of the table in Schedule 1 Part 2 to this Order during the times specified in that part unless that vehicle is proceeding in the direction specified in column (4) of that item and is of a type specified in column (5) of that item.

#### **PART 3 - EXEMPTIONS**

- 1. Part 2 does not apply to:
  - (a) A vehicle being used for Fire Brigade, Police or Ambulance purposes if the observance of any provisions of this Order would hinder the use of the vehicle for the purpose for which it is being used on that occasion;
  - (b) To such an extent and for such a time as it needed to comply with any requirement resulting from works of an emergency;
  - (c) A vehicle being used in the service of a local authority for the purpose of collecting refuse from premises adjacent to the bus lane;
  - (d) a security vehicle being used to transport cash or bullion;

- (e) a vehicle which is in the service of a universal service provider to deliver or collect postal packets as defined in section 125 (1) of the Postal Services Act 2000 to premises adjacent to the bus lane.
- (2) Part 2 shall not apply to any vehicle being used, if such use is necessary in connection with;
  - (a) any building operation or demolition on land adjacent to the bus lane;
  - (b) the removal of any obstruction to traffic;
  - (c) the maintenance, improvement or reconstruction of any road;
  - (d) the laying, erection, alteration or repair of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984 in or near any road;
  - (e) the placing, maintenance or removal or any traffic sign;
  - (f) any statutory powers or duties of a local authority.
- (3) A person who causes or permits a vehicle to be in a bus lane shall not contravene Part 2 if the vehicle enters the bus lane:
  - (a) in order to prevent an accident and the vehicle then leave the bus lane as soon as it is practicable;
  - (b) from a road which does not comprise the bus lane and forthwith leaves the bus lane through the gap in the single white line situated opposite and adjacent to that junction of that road with the bus lane or if there is no such gap, at a point opposite that road;
  - (c) from an adjacent part of the road through any gap in the single white line and forthwith enters a road which lies opposite that gap;
  - (d) from any vehicular access or crossing over the footway adjoining the bus lane and forthwith leaves the bus lane at a point opposite that vehicular access way or crossing;
  - (e) from an adjacent part of the road at a point opposite any vehicular access way or crossing over the footway adjoining the bus lane and forthwith enters that vehicular access way or crossing; or

- (f) Only for as long as may be necessary for the purposes of gaining access to or egress from off-street loading or garage facilities adjacent to the bus lane;
- (g) If and for as long as may be necessary to enable a person to get on or off the vehicle; or to enable goods to be loaded on to or unloaded from the vehicle in Western Road /North Street only
- (4) Anything done with the permission of at the direction of a police officer in uniform
