ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2008
Amendment Order No.2 2018**

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2 (1) to (3), 4, 45, 46, 49, 53 and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2008 Amendment Order No.2 2018 and shall come into operation on the *17th* day of *December* 2018.
2. The Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2008 is amended as follows:

SCHEDULE 1 AMENDMENTS

Part 3.1 Pay & Display Parking Places – Monday to Sunday 9.00am to 8.00pm

Delete the following:

Ref No.	Road Name	Side	Description
7	Kings Road	South	Extending from a point 7.6 metres east of a prolongation of the eastern kerbline of Western Street, westwards for a distance of 44.1 metres.
45	Marine Parade	North	From a point 17 metres east of the eastern kerbline of the western carriageway of Royal Crescent, eastwards to a point 3 metres west of the western kerbline of the eastern carriageway of Royal Crescent.

Replace with the following:

Ref No.	Road Name	Side	Description
7	Kings Road	South	From a point 7 metres east of the prolongation of the eastern kerbline of Western Street westwards for a distance of 35 metres.


Delete the following:

Ref No.	Road Name	Side	Description
6	Marine Parade	North	From a point 5 metres east of the eastern kerbline of the western carriageway of Royal Crescent eastwards for a distance of 6.6 metres.
7	Marine Parade	North	From a point 6 metres east of the eastern kerbline of the western carriageway of Royal Crescent eastwards for a distance of 11 metres (opposite Royal Crescent)
