**Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018
Amendment Order No.4 2019**

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2 (1) to (3), 4, 45, 46, 49, 53, 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 Amendment Order No.4 2019 and shall come into operation on the *15th* day of *August* 2019.
2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 is amended as follows:

ARTICLE AMENDMENTS

Part 4.2- Types of Permits

Delete following paragraph:-

- "27. A Resident shall be entitled to not more than 50 Resident's Visitor Permits in any 12 month period commencing from the date of issue of the first Resident's Visitor Permit to that Resident or 25 Resident's Visitor Permits if the Resident resides in CPZ "Y" or "Z" provided that:"

And replace with the following:-

- "27. A Resident shall be entitled to not more than 50 Resident's Visitor Permits in any 12 month period commencing from the date of issue of the first Resident's Visitor Permit to that Resident or 25 Resident's Visitor Permits if the Resident resides in CPZ "Y" or "Z", or 100 Resident's Visitor Permits if the Resident resides in CPZ "L", "S" or "W" provided that:"


