**BRIGHTON & HOVE VARIOUS CONTROLLED PARKING ZONES CONSOLIDATION
ORDER 2018 AMENDMENT ORDER No.6 2020**

Brighton & Hove City Council in exercise of its powers under sections 1(1), 2 (1) to (3), 4, 45, 46, 49, 53, and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 Amendment Order No.6 2020 and shall come into operation on the 8th day of June 2020.
2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 is amended as follows:

ARTICLE AMENDMENTS

PART 3 – PARKING PLACES

Delete the following:

"(16) Electric Vehicle Charging Points (Schedule 1 Part 19) for use by Electric Vehicles or Plug in Hybrid Vehicles which are displaying a valid Electric Vehicle Permit Only and in accordance with Part 4 of this Order"

Replace with the following:-

"(16) Electric Vehicle Charging Point (Schedule 1 Part 19) for use by Electric Vehicles or Plug in Hybrid Vehicles which are actively charging."
