ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018  
Amendment Order No.11 2020**

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 3, 4, 45, 46, 49, 53, and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004, Section 63 of the Local Government (Miscellaneous Provisions) Act 1976 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 Amendment Order No.11 2020 and shall come into operation on the 31st of August 2020.
2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 is amended as follows:

**ARTICLE AMENDMENTS**

The articles are amended as follows:

**PART 1 - GENERAL**

In paragraph 3 delete:-

- **"Electric Vehicle Permit"** means a Permit issued by the Council to a person registered with the Council's Electric Vehicle Scheme;
- **"Professional Carer Badge"** means a badge issued by the Council to a Professional Carer under the provisions of Part 4 of this Order;
- **"Waiver"** means a permission in writing issued by the Council at its discretion subject to the charge specified in Schedule 2 Part 1 for display in a vehicle permitting that vehicle to park in a specified Restricted Road or part of a Restricted Road on yellow lines.

And replace with:-

- **"Professional Carer's Permit"** means a permit issued by the Council to a Professional Carer under the provisions of Part 4 of this Order;

**PART 2 – WAITING OF VEHICLES**

In paragraph 2 delete:-

- (13) if the vehicle is displaying a valid Waiver issued for that vehicle and is left at a location and during a day and time period agreed by the

Council and is being used for a purpose for which the Waiver was issued.

- (14) if the vehicle is displaying a valid Professional Carer's Badge and has been left in such a place for no longer than one hour or such other period authorised by the Council and because no suitable Parking Place was available and if the vehicle is being used for a purpose for which the Professional Carer's Badge was issued
- (15) if the vehicle is being used in connection with the posting or removing of advertising material in the form of posters on or from, or the cleaning of windows or chimneys in, premises adjacent to that road and cannot reasonably be used for such purposes in any other road.

And replace with:

- (13) Not used
- (14) if the vehicle is displaying a valid Professional Carer's Permit and timeclock (on which the permit holder has indicated the time at which the period of waiting began) and is waiting for a period not exceeding two hours or such other period authorised by the Council and because no suitable Parking Place was available and if the vehicle is being used for a purpose for which the Professional Carer's Permit was issued.
- (15) if the vehicle is being used in connection with the posting or removing of advertising material in the form of posters on or from, premises adjacent to that road and cannot reasonably be used for such purposes in any other road.

Delete the following:-

- (i) in the case of Article 2 (12) and (13) a Dispensation or Waiver must be displayed in the front of the vehicle either on the inside of the windscreen or on the dashboard or fascia so that the details printed or written thereon on the front side are clearly visible and can be read in their entirety from the outside of the vehicle from the front or nearside.

And replace with :-

- (i) in the case of Article 2 (12) and (13) a Dispensation must be displayed in the front of the vehicle either on the inside of the windscreen or on the dashboard or fascia so that the details printed or written thereon on the front side are clearly visible and can be read in their entirety from the outside of the vehicle from the front or nearside.

Delete the following:-

- (ii) in the case of Article 2 (14) a Professional Carer's Badge must be displayed in accordance with the provisions of Part 4.1 Article 8 (ii).

And replace with:-

(ii) in the case of Article 2 (14) a Professional Carer's Permit must be displayed in accordance with the provisions of Part 4.1 Article 8 (ii).

Delete the following :-

- (iv) no vehicle except in the case of Article 2 (4) (5) and (7) of this Part shall wait in any part of a Restricted Road specified in Schedule 1 Parts 2 and 3 for each of the Controlled Parking Zones referred to therein during the Prescribed Hours for any purpose unless notice is given 48 hours in advance to the Council and a Waiver has been issued in accordance with Article 2 (13) of this Part.

And replace with :-

- (iv) no vehicle except in the case of Article 2 (4) (5) and (7) of this Part shall wait in any part of a Restricted Road specified in Schedule 1 Parts 2 and 3 for each of the Controlled Parking Zones referred to therein during the Prescribed Hours for any purpose

### **PART 3 – PARKING PLACES**

In paragraph 1 delete:-

- (1) Permit Parking Places (Schedule 1 Part 4) for use by vehicles displaying a valid Resident's, Business, Carer's, Trader's, School, Resident's Visitor or Hotel Guest Permit or a Professional Carer's Badge only and in accordance with Part 4 of this Order.
- (16) Electric Vehicle Charging Points ( Schedule 1 Part 19) for use by Electric Vehicles or Plug in Hybrid Vehicles which are displaying a valid Electric Vehicle Permit only and in accordance with Part 4 of this Order.

And replace with:-

- (1) Permit Parking Places (Schedule 1 Part 4) for use by vehicles displaying a valid Resident's, Business, Carer's, Trader's, School, Resident's Visitor or Hotel Guest Permit or a Professional Carer's Permit only and in accordance with Part 4 of this Order.
- (16) Electric Vehicle Charging Points ( Schedule 1 Part 19) for use by Electric Vehicles or Plug in Hybrid Vehicles only in accordance with Part 4 of this Order.

### **PART 4 – PARKING PERMITS**

#### **PART 4.1 - General**

##### **Permit Particulars**

In Paragraph 7 delete the following:-

- (i) for School Permits, Doctor's Permits and Professional Carer's Badges Article 7 (1) of this Part shall not apply.
- (ii) for Professional Carer's Badges, Electric Vehicle Permits and Trader's Permits Article 7 (4) of this Part shall not apply.

And replace with :-

- (i) for School Permits , Doctor's Permits and Professional Carer's Permits Article 7 (1) of this Part shall not apply.
- (ii) for Professional Carer's Permits and Trader's Permits Article 7 (4) of this Part shall not apply.

### **Display of Permit**

In paragraph 8 delete the following:-

- (ii) in the case of a Professional Carer's Badge the badge may be displayed as referred to herein or alternatively suspended from the Driver's rear view mirror in a plastic holder provided by the Council for that purpose provided that the particulars referred to in Article 7 of this Part are visible and can be read in their entirety from the outside of the vehicle either from the front or nearside.

And replace with:-

- (ii) in the case of a Professional Carer's Permit; the permit must be displayed in the timeclock provided by the Council. The permit and timeclock must be visible on the dashboard and able to be read in their entirety from the outside of the vehicle either from the front or nearside.

### **Part 4.2 Types of Permit**

#### **Trader's Permits**

In Paragraph 22 delete the following:-

22. The issue and display of a valid Trader's Permit allows the Permit Holder to park the vehicle during the Prescribed Hours in a Permit Parking Place until 5pm or in a Pay & Display Parking Place as identified in Schedule 1 Parts 4, 5 and 6 respectively provided that the vehicle is being used for a purpose for which the Permit was issued.

And replace with :-

22. The issue and display of a valid Trader's Permit allows the Permit Holder to park the vehicle during the Prescribed Hours in a Permit Parking Place until 5pm or in a Pay & Display Parking Place as identified in Schedule 1 Parts 4, 5 and 6 or in the case of a light touch zone, the Permit Holder can park within the restricted

hours of a Permit Parking Place, provided that the vehicle is being used for a purpose for which the Permit was issued.

After paragraph 33 delete the following:-

### **Professional Carer's Badge**

And replace with

### **Professional Carer's Permit**

Delete the following paragraphs:-

34. Any Professional Carer or organisation employing Professional Carer's may apply for a Professional Carer's Badge and shall produce such evidence in support of the application as may be reasonably required by the Council to verify any particulars or information given.

35 .The issue and display of a Professional Carer's Badge allows the Professional Carer to park a vehicle during the Prescribed Hours in a Permit Parking Place or a Pay & Display Parking Place identified in Schedule 1 Parts 4, 5 and 6 (inclusive) for up to one hour or such other period authorised by the Council or, if there is no such place available, in a Restricted Road (on yellow lines) identified in Schedule 1 Part 1 for up to one hour or such other period authorised by the Council provided that it is not left in a position that causes an obstruction or danger to others.

PROVIDED that the vehicle is being used for a purpose for which the badge was issued.

And replace with:-

34. Any Professional Carer or organisation employing Professional Carers may apply for a Professional Carer's Permit and shall produce such evidence in support of the application as may be reasonably required by the Council to verify any particulars or information given.

35 .The issue and display of a Professional Carer's Permit allows the Professional Carer to park a vehicle during the Prescribed Hours in a Permit Parking Place or a Pay & Display Parking Place identified in Schedule 1 Parts 4, 5 and 6 (inclusive) for up to two hours or such other period authorised by the Council or, if there is no such place available, in a Restricted Road (on yellow lines) identified in Schedule 1 Part 1 for up to two hours or such other period authorised by the Council provided that it is not left in a position that causes an obstruction or danger to others.

PROVIDED that the vehicle is being used for a purpose for which the badge was issued.

**Delete Electric Vehicle Permits title and following paragraphs:-**

36. Any applicant for an Electric Vehicle Permit shall produce the Vehicle Registration Certificate and such other evidence as may be required by the Council to satisfy itself that the vehicle for which the application is made falls within the definition of Electric Vehicle or Plug in Hybrid Vehicle used in this Order and that the vehicle is registered in the name of the applicant at their current place of residence or business address.

PROVIDED that an applicant whose name and address are not shown on the Vehicle Registration Certificate only because the vehicle is registered in the name of his employer or because it is hired or leased to him shall not be prevented from applying for a Permit.

37. The issue and display of a valid Electric Vehicle Permit allows the Permit Holder to park the Electric Vehicle or Plug in Hybrid Vehicle during the Prescribed Hours in an Electric Vehicle Charging Point identified in Schedule 1 Part 19 whilst connected by the charging lead supplied by the Council to and actively charging from the charging apparatus relating to that charging point only.

Add in after 36. NOT USED

## **PART 5 – PAY & DISPLAY PARKING**

Delete the following:-

- (4) those vehicles that display a valid Professional Carer's Badge may be left in any of the Parking Places specified in Schedule1 Parts 5 and 6 with exemption from payment of the charges for a maximum period of one hour or such other period authorised by the Council provided that the vehicle is being used for the purposes for which the badge has been issued.

And replace with :-

- (4) those vehicles that display a valid Professional Carer's Permit may be left in any of the Parking Places specified in Schedule1 Parts 5 and 6 with exemption from payment of the charges for a maximum period of two hours or such other period authorised by the Council provided that the vehicle is being used for the purposes for which the permit has been issued.
