

**BRIGHTON & HOVE CITY COUNCIL  
ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018  
Amendment Order No.16 2020**

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 3, 4, 45, 46, 49, 53, and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004, Section 63 of the Local Government (Miscellaneous Provisions) Act 1976 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 Amendment Order No.16 2020 and shall come into operation on the 4<sup>th</sup> day of January 2021.
2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 is amended as follows:

**ARTICLE AMENDMENTS**

The articles are amended as follows:

**PART 1 - GENERAL**

In paragraph 3 delete:

**"Carer's Permit"** means a Permit issued by the Council to a Carer under the provisions of Part 4 of this Order;

**"Dispensation"** means a permission in writing constrained by time issued by the Council at its discretion subject to the charge specified in Schedule 2 Part 1 for display in a vehicle permitting that vehicle to be left in a Restricted Road on yellow lines subject to the provisions of this Order;

And replace with:

**"Carer's Permit"** means a Permit issued by the Council to the cared for under the provisions of Part 4 of this Order

**"Dispensation Permit"** means a permission in writing constrained by time issued by the Council at its discretion subject to the charge specified in Schedule 2 Part 1 for display in a vehicle permitting that vehicle to be left in a Restricted Road on yellow lines or a permit parking place as specified in Schedule 1 parts 4 and 5 subject to the provisions of this Order;

## **PART 2 – WAITING OF VEHICLES**

In paragraph 2 delete (12):

(12) if the vehicle is displaying a valid Dispensation issued for that vehicle and is left for a period not exceeding 20 minutes or such other period specified by the Council on the Dispensation and is being used for a purpose for which the Dispensation was issued.

And replace with:

(12) if the vehicle is displaying a valid permit and timeclock (on which the permit holder has indicated the time at which the period of waiting began) and is left for a period not exceeding 30 minutes and is being used for a purpose for which the Dispensation Permit was issued.

In paragraph 2 after " Provided that" delete:

- (i) in the case of Article 2 (12) and (13) a Dispensation must be displayed in the front of the vehicle either on the inside of the windscreen or on the dashboard or fascia so that the details printed or written thereon on the front side are clearly visible and can be read in their entirety from the outside of the vehicle from the front or nearside.

And replace with:

- (i) in the case of Article 2 (12) a Dispensation permit must be displayed in the timeclock provided by the Council. The permit and timeclock must be visible on the dashboard and able to be read in their entirety from the outside of the vehicle either from the front or nearside.

## **PART 3- PARKING PLACES**

In paragraph 1. Delete the following:

- (1) Permit Parking Places (Schedule 1 Part 4) for use by vehicles displaying a valid Resident's, Business, Carer's, Trader's, School, Resident's Visitor or Hotel Guest Permit or a Professional Carer's Permit only and in accordance with Part 4 of this Order

And replace with the following:

- (1) Permit Parking Places (Schedule 1 Part 4) for use by vehicles displaying a valid Resident's, Business, Carer's, Trader's, Dispensation, School, Resident's Visitor or Hotel Guest Permit or a Professional Carer's Permit only and in accordance with Part 4 of this Order.

## **PART 4 – PARKING PERMITS**

## **Part 4.2 Types of Permit**

### **Carer's Permits**

In paragraph 18 delete:

- (1) the applicant is a Carer and that the person or persons that they care for is/are Resident within the CPZ for which the Permit is being applied for.

and replace with:

- (1) the person or persons being cared for is/are a Resident within the CPZ for which the Permit is being applied for

### **School Permits**

Delete the following paragraph:

24. No Permit shall be issued if the school has off-street parking facilities available or allocated for the use of its teaching staff at the school premises or elsewhere within the CPZ for which the Permit has been applied for.

Add the following new paragraphs:

### **Dispensation Permit**

36. Any applicant for a Dispensation Permit shall produce such evidence as may be required by the Council to satisfy itself that:
  - (1) The applicant is providing essential services in the city to keep it running or;
  - (2) The applicant is a council worker and is required to make short and frequent stops throughout the city to provide essential services
37. The issue and display of a Dispensation Permit allows the permit holder to park a vehicle during the Prescribed Hours in a Permit Parking Place identified in Schedule 1 Parts 4 and 5 for up to one hour or, if there is no such place available, in a Restricted Road (on yellow lines) identified in Schedule 1 Part 1 for up to 30 minutes provided that it is not left in a position that causes an obstruction or danger to others and that the vehicle is being used for a purpose for which the permit was issued.
