BRIGHTON & HOVE CITY COUNCIL ROAD TRAFFIC REGULATION ACT 1984

Brighton & Hove (Various Restrictions) (Temple Street) Experimental Order 2020

Brighton & Hove City Council in exercise of its powers under sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") as amended and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

- 1. This Order shall be cited as the "Brighton and Hove (Various Restrictions) (Temple Street) Experimental Order 2020".
- 2. The provisions of this Order will come into operation on the 23rd day of December 2020.
- 3. In this Order, except where the context otherwise requires, the following expressions have the meanings assigned to them:-
- "Pedal cycle" has the same meaning as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;
- "Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on roads subject to Section 20 Chronically Sick and Disabled Persons Act 1970;
- "Road marking" means a traffic sign consisting of a line or mark or legend on the surface on the road of a size, colour and type prescribed or authorised under Section 64 of the Road Traffic Regulation Act 1984;
- "Traffic Signs Regulation and General Directions" means the Traffic Signs Regulation and General Directions 2016 as amended from time to time;
- "Traffic Sign" means a sign of a size, colour and type prescribed or authorised under, or having an effect as though prescribed or authorised under Section 64 of the Road Traffic Regulation Act 1984;
- Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated or reenacted by or as having effect by virtue of any subsequent enactment.
- In so far as any provision of this Order conflicts with a provision which is contained in an Order made or having effect as if made under the Act, and existing when this Order comes into operation, and which imposes a

- restriction or prohibition on movement by vehicles or grants an exemption from such restriction or prohibition, the provisions of this Order shall prevail.
- 6. No person shall except upon the direction or with the permission of a police officer in uniform cause or permit any motor vehicle to proceed in those parts of road specified in columns 2 and 3 in Schedule 1 other than a pedal cycle.
