#### ROAD TRAFFIC REGULATION ACT 1984 BRIGHTON & HOVE CITY COUNCIL

#### Brighton & Hove (Bus Lanes) Consolidation Order 2018 Amendment Order No.1 2021

Brighton & Hove City Council in exercise of its powers under Sections 1 (1), 2(1) to (3), 4 (1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act ("the Act") as amended and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby makes the above named Order.

- 1. This Order may be cited as the Brighton & Hove (Bus Lanes) Consolidation Order 2018 Amendment Order No.1 2021 and shall come into operation on the 22<sup>nd</sup> February 2021.
- 2. The Council's Executive Director Economy, Environment & Culture or any person authorised by him is authorised to modify or suspend the operation of this Order or any provision of it in accordance with the provisions of section 10(2) of the Act.
- 3. The Brighton & Hove (Bus Lanes) Consolidation Order 2018 is amended as follows:

#### **ARTICLE AMENDMENTS**

#### PART 1 - GENERAL

Paragraph 3

Delete existing definition:

"Bus-only route" means a traffic lane that may be used only by buses;

Replace with:

"Bus-only route" means a traffic lane that may be used only by buses (or a particular description of bus) and some other class or classes of vehicular traffic as provided for in this order;

#### PART 2 – BUS LANE TRAFFIC RESTRICTIONS

Paragraph 1 delete:

1. Subject to the provisions of Article 1 of Part 3 no person shall cause a vehicle to be in the lengths of road specified in column (2) Schedule 1 to this Order, during the hours specified in that part, unless that vehicle is proceeding in the direction specified in column (4) of that item and is of a type specified in column (5) of that item.

#### And replace with:

Subject to the provisions of Part 3 no person shall cause a vehicle to be in the lengths of road specified in column (2) Schedule 1 to this Order, during the hours specified in that part, unless that vehicle is proceeding in the direction specified in column (4) of that item and is of a type specified in column (5) of that item.

#### Paragraph 2 delete:

2. Subject to the provisions of Article 1 of Part 3 no person shall cause a vehicle to be in a length of road specified in an item in column (2) of the table in Schedule 1 Part 2 to this Order during the times specified in that part unless that vehicle is proceeding in the direction specified in column (4) of that item and is of a type specified in column (5) of that item.

#### And replace with:

2. Subject to the provisions of Part 3 no person shall cause a vehicle to be in a length of road specified in an item in column (2) of the table in Schedule 1 Part 2 to this Order during the times specified in that part unless that vehicle is proceeding in the direction specified in column (4) of that item and is of a type specified in column (5) of that item.

#### Add new paragraph:

3. Subject to the provisions of Article 1 and 2 Part 3 no person shall cause a vehicle to proceed in the length of road specified in column 2 and 3 of Schedule 1 Part 3 of this order, during the times specified in that part unless the vehicle is proceeding in the direction specified in column (4) of that item and is of a type specified in column (5) of that item.

If and for as long as may be necessary to enable a person to get on or off the vehicle; or to enable goods to be loaded on to or unloaded from the vehicle in Western Road /North Street only

#### And replace with:

(g) To enable goods to be loaded on to or unloaded from the vehicle in Western Road /North Street only

#### After (4) add the following:

- 2. (1) Article 2 Part 2 does not apply to:
  - (a) A vehicle being used for Fire Brigade, Police or Ambulance purposes if the observance of any provisions of this Order would hinder the use of the vehicle for the purpose for which it is being used on that occasion;
  - (b) To such an extent and for such a time as it needed to comply with any requirement resulting from works of an emergency;
  - (c) A vehicle being used in the service of a local authority for the purpose of collecting refuse from premises adjacent to the bus lane;
  - (d) a security vehicle being used to transport cash or bullion;
  - (e) a vehicle which is in the service of a universal service provider to deliver or collect postal packets as defined in section 125 (1) of the Postal Services Act 2000 to premises adjacent to the bus lane.
  - (2) Article 2 Part 2 shall not apply to any vehicle being used, if such use is necessary in connection with;
    - (a) any building operation or demolition on land adjacent to the bus only route;
    - (b) the removal of any obstruction to traffic;
    - (c) the maintenance, improvement or reconstruction of any road;
    - (e) the laying, erection, alteration or repair of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984 in or near any road;
    - (e) the placing, maintenance or removal or any traffic sign;
    - (f) any statutory powers or duties of a local authority.
  - (3) A person who causes or permits a vehicle to be in a bus only route shall not contravene Part 2 if the vehicle enters the bus only route:

- (a) in order to prevent an accident and the vehicle then leave the bus only route as soon as it is practicable;
- (b) from a road which does not comprise the bus only route and forthwith leaves the bus only route situated opposite and adjacent to that junction of that road with the bus only route or at a point opposite that road;
- (c) from an adjacent part of the road and forthwith enters a road which lies opposite the bus only route;
- (d) from any vehicular access or crossing over the footway adjoining the bus only route and forthwith leaves the bus only route at a point opposite that vehicular access way or crossing;
- (e) from an adjacent part of the road at a point opposite any vehicular access way or crossing over the footway adjoining the bus only route and forthwith enters that vehicular access way or crossing; or
- (f) Only for as long as may be necessary for the purposes of gaining access to or egress from off-street loading or garage facilities adjacent to the bus only route;
- (g) To enable goods to be loaded on to or unloaded from the vehicle in Western Road /North Street only
- (4) Anything done with the permission of at the direction of a police officer in uniform
- 3. (1) Article 3 Part 2 does not apply to:
  - (a) A vehicle being used for Fire Brigade, Police or Ambulance purposes if the observance of any provisions of this Order would hinder the use of the vehicle for the purpose for which it is being used on that occasion;
  - (b) To such an extent and for such a time as it needed to comply with any requirement resulting from works of an emergency;
  - (c) A vehicle being used in the service of a local authority for the purpose of collecting refuse from premises adjacent to the bus lane;
  - (d) a security vehicle being used to transport cash or bullion;
  - (e) a vehicle which is in the service of a universal service provider to deliver or collect postal packets as defined in section 125 (1) of the Postal Services Act 2000 to premises adjacent to the bus lane.
  - (2) Article 3 Part 2 shall not apply to any vehicle being used, if such use is necessary in connection with;
    - (a) any building operation or demolition on land adjacent to the bus gate;

- (b) the removal of any obstruction to traffic;
- (c) the maintenance, improvement or reconstruction of any road;
- (d) the laying, erection, alteration or repair of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984 in or near any road;
- (e) the placing, maintenance or removal or any traffic sign;
- (f) any statutory powers or duties of a local authority.
- (3) A person who causes or permits a vehicle to go through the bus gate shall not contravene Part 2 if the vehicle enters the bus gate:
  - (b) in order to prevent an accident and the vehicle then leaves that route as soon as it is practicable;
- (4) Anything done with the permission of at the direction of a police officer in uniform
