**BRIGHTON & HOVE VARIOUS CONTROLLED PARKING ZONES CONSOLIDATION  
ORDER 2018 AMENDMENT ORDER No.5 2021**

Brighton & Hove City Council in exercise of its powers under sections 1(1), 2 (1) to (3), 4, 45, 46, 49, 53, and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 Amendment Order No.5 2021 and shall come into operation on the 1<sup>st</sup> day of March 2021.
2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 is amended as follows:

**ARTICLE AMENDMENTS**

**PART 1 – GENERAL**

In paragraph 3 - between "Electric Vehicle Scheme" and "Exclusive Pay & Display Parking Bay" insert: -

- **"E-Taxi Vehicle"** means a taxi vehicle in which the electrical motive power is derived from an electrical storage battery which is not connected to any source of power when the vehicle is in motion;
- **"E-Taxi Vehicle Charging Point"** means a length of road indicated by Traffic Signs authorising it to be used for the leaving of vehicles in accordance with the provisions of this order;

**PART 3 – PARKING PLACES**

Delete the following:

"(16) Electric Vehicle Charging Points (Schedule 1 Part 19) for use by Electric Vehicles or Plug in Hybrid Vehicles only in accordance with Part 4 of this Order"

Replace with the following: -

"(16) Electric Vehicle Charging Points (Schedule 1 Part 19) for use by Electric Vehicles or Plug in Hybrid Vehicles which are actively charging"

After (16) Electric Vehicle Charging Points, insert the following: -

"(17) E-Taxi Vehicle Charging Points (Schedule 1 Part 19) for use by E-Taxi Vehicles which are actively charging."

After existing Part 19.1 add new “Part 19.3 E-Taxi Charging Point” Add “C & J” into the CPZ Column
