Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2018 Amendment Order No.11 2021

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2 (1) to (3), 4, and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as the Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2018 Amendment Order No.11 2021 and shall come into operation on the 23rd day of August 2021.
2. The Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2018 is amended as follows:

7a	Ladies Mile Road	South	From a point 68.4 metres east of the eastern kerbline of Winfield Avenue eastwards for a distance of 5.5 metres

2	Ladies Mile Road	South	From a point 56.4 metres east of the eastern kerbline of Winfield Avenue eastwards for a distance of 12 metres
3	South Street - Portslade		From a point 6.4 metres north of the kerbline of High Street northwards for a distance of 8.8 metres
