

**BRIGHTON & HOVE CITY COUNCIL
ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove (Stanmer Park) Various Restrictions and Off-Road Parking Order
2020 Amendment Order No.2 2021**

Brighton & Hove City Council ("the Council") in exercise of their powers under section 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1. This Order may be cited as the Brighton & Hove (Stanmer Park) Various Restrictions and Off-Road Parking Order 2020 Amendment Order No. 2 2021 and shall come into operation on the 18th day of September 2021.
2. Brighton & Hove (Stanmer Park) Various Restrictions and Off-Road Parking Order 2020 is amended as follows:

ARTICLE AMENDMENTS

Part 1 – General

Paragraph 2 add the following after **"Penalty Charge Notice"**

"Plumpton College Permit" means a permission in writing issued by Plumpton College at its absolute discretion for students and visitors, allowing a vehicle to park or wait in the Patchway Car Parking areas during term time;

Part 3 - Car Park Areas

In Paragraph 6 delete the following:

- (e) a vehicle is parking in a parking place in Patchway Car park (including Patchway A & B when necessary) to a vehicle which is displaying a valid Hotel Permit.

and replace with:

- (e) a vehicle is parking in a parking place in Patchway Car park (including Patchway A & B when necessary) to a vehicle which is displaying a valid Plumpton College Permit (term time only) or Hotel Permit.

Add new Paragraph 9 as follows

9. The Council may, at its discretion, allow overflow car parks to be used without payment as and when is required for parking for vehicles of volunteers working in Stanmer Park.

Part 4 – Stanmer Estate Road Restrictions

In Paragraph 2 delete the following:

(3) Drop off and Pick up point; for use by vehicles for the purpose of picking up or dropping off of passengers or goods at any time.

Replace with:

(3) Limited Waiting Parking Places; for use by vehicles waiting no longer than the period specified in the Schedule with no return allowed before the expiration of the period specified in the Schedule from the time the same vehicle has been moved from such a Parking Place. Vehicles that display in the Relevant Position a valid Disabled Person's Badge may be left in these places without any limits on time provided that the badge is being used in accordance with the provisions of the Blue Badge Scheme.

SCHEDULE 1 AMENDMENTS

After Part 1.1 No Stopping, Waiting or Loading at any time add "(Restricted Zone – signed only)"

Part 1.2 Loading Bays at any time

Delete the following:

Item	Road	Side	Description
1	Stanmer Estate Road (access road to Walled Garden)	South	From the flank wall of No.8 westwards (Outside the Museum)
2	Stanmer Estate Road (access road to Walled Garden)	North	At the western end of the Walled Gardens

Replace with:

Item	Road	Side	Description
1	Stanmer Estate Road (access road to Walled Garden)	South	From the western side of the Museum access for 8.6 metres westwards. (Outside the Museum)

Delete the following:

Part 1.3 Pick up and drop off point at any time

Item	Road	Side	Description
1	Stanmer Estate Road (eastern road to Stanmer House)	North-East	From the southern flank wall of Stanmer House north-westwards for 30 metres.

Replace with:

Part 1.3 Limited Waiting for 30 minutes (No return within 1 hour) Monday to Sunday 9am to 8pm

Item	Road	Side	Description
1	Stanmer Estate Road (eastern road to Stanmer House)	North-East	Opposite the southern flank wall of Stanmer House in the layby adjacent to the lawn north-westwards for 30 metres.


