# Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2018 Amendment Order No.2 2021

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2 (1) to (3), 4, 45, 46, 49, 53 and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

- 1. This Order may be cited as Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2018 Amendment Order No.2 2021 and shall come into operation on the 1<sup>st</sup> day of January 2022.
- 2. The Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2018 is amended as follows:

#### **ARTICLE AMENDMENTS:**

#### Part 2 - Waiting of Vehicles

Add new article as follows:-

3. In the case of the roads specified in Schedule 11.1 Restricted Zones, the Secretary of State for Transport in exercise of his powers under Sections 64 and 65 of the Act has authorised and directed that only traffic signs and not road markings are to be used to identify the restrictions referred to therein.

### Part 1.1 No Waiting At Any Time

Add new item:

#### Part 2.2 No loading/unloading at Any time

Add new item:

2	Undercliff Walk	Both	From the southern kerbline of Marine Drive to a point 51 metres west of the western building line of Whitecliffs Café

#### Part 5.1 Disabled Badge Holders Parking Place At Any Time

Add new item:

Ref no	Road Name	Side	Description
5	Undercliff Walk	North	From a point 2.5 metres west of the western building line of the public convenience building, westwards for a distance of 11 metres.
6	Undercliff Walk	South	From a point 1 metre west of the western building line of the public convenience building, eastwards for a distance of 6.6 metres.

### Part 7.1 Loading Only At Any Time

Add new item:

Ref no	Road Name	Side	Description
5	Undercliff Walk	North	From a point 13.5 metres west of the western building line of the public convenience building westwards for a distance of 8 metres

## Part 7.2 Loading Only 24 hours of any day - 30 minutes (No return within 1 hour)

Add new item:

Ref no	Road Name	Side	Description
3	Marine Parade	South	From a point 41.5 metres east of a prolongation of the western kerbline of Charles Street eastwards for a distance of 23.5 metres.
