ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2018 Amendment  
Order No.1 2022**

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2 (1), 4, 45, 46, 49, 53, 124 (1) (c) & (d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2018 Amendment Order No.1 2022 and shall come into operation on the 17th day of January 2022.
2. The Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2018 is amended as follows:

**SCHEDULE AMENDMENTS**

**Part 3.1 Pay and Display Parking Place – Monday to Sunday 9am to 8pm**

Delete the following:

<b>Item No.</b>	<b>Road</b>	<b>Side</b>	<b>Description</b>	<b>Max. Period for which vehicles may wait</b>
4	King's Road	South	Extending from a point 7.5 metres east of a prolongation of the western kerbline of Ship Street, westwards for a distance of 49.5 metres	24hrs
5	King's Road	South	Extending from a point 81 metres west of a prolongation of the western kerbline of Preston Street, westwards for a distance of 60.5 metres	24hrs
6	King's Road	South	Extending from a point 1 metre west of a prolongation of the western kerbline of the western carriageway of Bedford Square, westwards for a distance of 22 metres	24hrs
7	King's Road	South	From a point 7 metres east of the prolongation of the eastern kerbline of Western Street westwards for a distance of 35 metres	24hrs

Add the following:

Item No.	Road	Side	Description	Max. Period for which vehicles may wait
4	King's Road	South	Extending from a point 84 metres west of a prolongation of the western kerbline of Preston Street, westwards for a distance of 46 metres – floating bay -set back from kerbline by 2.8 metres.	24 hours

### Part 5.1 Disabled Badge Holders Parking Places At Any Time

Delete the following:

Item No.	Road	Side	Description
1	King's Road	South	Extending from a point 24 metres west of the western kerbline of Bedford Square westwards for a distance of 26.4 metres

Add the following:

Item No.	Road	Side	Description
1	King's Road	South	Extending from a point 5 metres west of the prolongation of the western kerbline of the western arm of Bedford Square westwards for a distance of 26 metres - floating bay set back from kerbline by 3 metres.

### Part 6.1 Motorcycles Parking Places At Any Time

Delete the following:

Item No.	Road	Side	Description
2	King's Road	South	Extending from a point 46 metres west of a prolongation of the western kerbline of the western carriageway of Bedford Square westwards for a distance of 6.5 metres

### Part 7.2 Loading Only 24 hours of any day – 30 minutes (No Return within 1 hour)

Delete the following:

Item No.	Road	Side	Description
2	King's Road	South	From a point 9.5 metres west of the prolongation of the western kerbline of eastern arm of Bedford Square westwards for a distance of 19.6 metres

Add the following:

Item No.	Road	Side	Description
2	King's Road	South	Extending from a point 5 metres west of the prolongation of the western kerbline of the western arm of Bedford Square eastwards for a distance of 18 metres- floating bay set back from kerbline by 3 metres.

#### Part 8.1 Taxi Rank At Any Time

Delete the following:

Item No.	Road	Side	Description
5	Marine Parade	South	From a point 20.5 metres east of a prolongation of the western kerbline of Charles Street eastwards for a distance of 21 metres.

Add the following:

Item No.	Road	Side	Description
5	Marine Parade	South	From a point 32.5 metres east of a prolongation of the western kerbline of Charles Street eastwards for a distance of 21 metres.

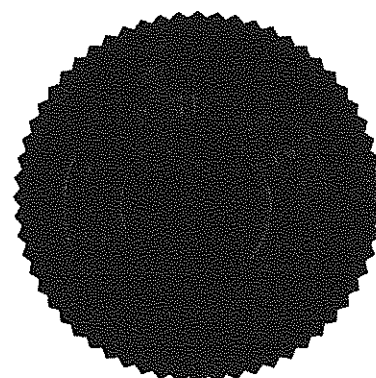
