

**BRIGHTON & HOVE CITY COUNCIL  
ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes  
Consolidation Order 2018 Amendment Order No.5 2022**

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2 (1) and (2) , 4, 124 (1) (c) & (d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2018 Amendment Order No.5 2022 and shall come into operation on the 11th day of April 2022.
2. The Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2018 is amended as follows:

697b	Foxdown Road	West	From the northern kerbline of Hunston Close northwards for a distance of 7.5 metres
697c	Foxdown Road	West	From the southern kerbline of Hunston Close southwards for a distance of 7.5 metres
697d	Foxdown Road	West	From the northern kerbline of Larch Close northwards for a distance of 8 metres
697e	Foxdown Road	West	From the southern kerbline of Larch Close southwards for a distance of 8 metres
1097b	Horton Road	East	From the northern kerbline of Major Close northwards for a distance of 10 metres
1097c	Horton Road	East	From the southern kerbline of Major Close southwards for a distance of 10 metres
1097d	Horton Road	West	From the northern kerbline of Wigmore Close northwards for a distance of 10 metres
1097e	Horton Road	West	From the southern kerbline of Wigmore Close southwards for a distance of 10 metres

1332	Maple Gardens	East & North	From the southern kerbline of Elm Drive southwards then eastwards to the western kerbline of Acacia Avenue

2246a	Tintern Close	Both	From the eastern kerbline of Horton Road eastwards for a distance of 10 metres
2511a	Wigmore Close	Both	From the western kerbline of Horton Road westwards for a distance of 10 metres
2555a	Withdean Rise	North	From the western kerbline of the access road between Nos.1-8 & Nos.73-80 Regency Court westwards for a distance of 7 metres
2555b	Withdean Rise	North	From the eastern kerbline of the access road between Nos.1-8 & Nos.73-80 Regency Court eastwards to the western kerbline of Withdean Rise
2555c	Withdean Rise	West	From the northern kerbline of Withdean Rise (near Nos.73-80 Regency Court) northwards for a distance of 11.5 metres

721	Freehold Terrace	South	From the western kerbline of Popes Folly westwards for a distance of 5 metres

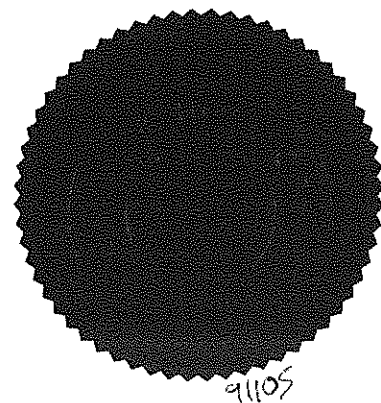
