**BRIGHTON & HOVE VARIOUS CONTROLLED PARKING ZONES
CONSOLIDATION ORDER 2018 AMENDMENT ORDER No.2 2024 (ref: TRO-9-
2023)**

Brighton & Hove City Council in exercise of its powers under sections 1(1), 2 (1) and (2), 4, 45, 46, 49, 53, 124 (1) (c) & (d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 Amendment Order No.2 2024 and shall come into operation on the 22nd day of January 2024.
2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 is amended as follows:

ARTICLE AMENDMENTS

PART 10 – INDEX OF SCHEDULE 1

PART 3 – PARKING PLACES

In paragraph (16) add the following:

(e) Schedule 1 Part 19.5 for use by E-Taxi Vehicles only which are actively charging for a maximum of 1 hour (No return within 2 hours)

(f) Schedule 1 Part 19.6 for use by Electric Vehicles or Plug-in Hybrid Vehicles only which are actively charging for a maximum of 1 hour (No return with 2 hours)

Part 19– Electric Vehicle Charging Points-

In Part 19.5 and 19.6 Add "S" into the CPZ Column

SCHEDULE 1 AMENDMENTS:

Schedule 1 is amended as follows:

Controlled Parking Zone S

Part 13.1 – Taxi Ranks At Any Time

Delete the following item:

Add the following item:

1	Elm Grove	South	From a point 115.8 metres west of the western kerbline of Freshfield Road, westwards for 10.8 metres.	S

**Part 19.5 Electric Vehicle Charging Points At Any Time – E-Taxis only
Maximum Stay 1 hour (No return within 2 hours).**

Add the following items:

2	Elm Grove	South	From a point 93.3 metres west of the western kerbline of Freshfield Road westwards for 6.6 metres.	S
4	Elm Grove	South	From a point 109.2 metres west of the western kerbline of Freshfield Road westwards for 6.6 metres.	S

**Part 19.6 Electric Vehicle Charging Points At Any Time –Maximum Stay 1 hour
(No return within 2 hours).**

Add the following items:


