ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove Various Controlled Parking Zones Consolidation Order
2018 Amendment Order No.7 2024 (TRO-51-2023)**

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) and (2), 4, 45, 46, 49, 53, 124 (1) (c) & (d) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as the Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 Amendment Order No. 7 2024 and shall come into operation on the 29th day of January 2024.
2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 is amended as follows:

ARTICLE AMENDMENTS

PART 4 – PARKING PERMITS

Part 4.2 – Types of Permit

Residents Permits

In paragraph 2. delete the following:

- (2) the Vehicle Registration Certificate for the Motor Vehicle to show that it is registered in the name of the applicant and at the place of residence within the CPZ for which the Permit is required, if this cannot be provided proof must be given that the vehicle has insurance registered at that address in the applicant's name.

And replace with the following:

- (2) the Vehicle Insurance Schedule for the Motor Vehicle to show that it is registered in the name of the applicant and at the place of residence within the CPZ for which the Permit is required.

Delete paragraph 3. as follows:

3. No Permit shall be issued if the applicant has off-street parking facilities available or allocated for the vehicle at the place of residence or elsewhere within the CPZ for which the Permit has been applied for.

And replace with new paragraph 3. as follows:

3. If the applicant has off-street parking facilities available or allocated for the vehicle at the place of residence or elsewhere within the CPZ for which the Permit has been applied for, it will be at the Council's discretion whether a Permit will be issued.
