

## BRIGHTON & HOVE CITY COUNCIL

### Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2024 Amendment Order No.4 2024 (ref: TRO-28b-2024)

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) and (2), 4, 45, 46, 49, 53, 124(1)(c) & (d) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as the Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2024 Amendment Order No.4 2024 and shall come into operation on the 4th day of November 2024.
2. Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2024 is amended as follows:


