ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes
Consolidation Order 2024 Amendment Order No.1 2025 (ref: TRO-33b-2024)**

Brighton & Hove City Council (“the Council”) in exercise of its powers under Sections 1(1), 2(1) to (3), 4, and 124(1)(c) & (d) to the Road Traffic Regulation Act 1984 (“the 1984 Act”) as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as the Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2024 Amendment Order No.1 2025 and shall come into operation on the 3rd day of February 2025.
2. The Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2024 is amended as follows:

SCHEDULE 1 AMENDMENTS:

Part 1.1 No Waiting at Any Time

Delete the following items:

Item No.	Road Name	Side	Description
2160	Southall Avenue	Both	From the north-eastern kerblines of Natal Road north-eastwards for 37.5 metres
2161	Southall Avenue	South	From the western kerblines of Southall Avenue westwards for 14 metres
2162	Southall Avenue	North	From the western kerblines of Southall Avenue westwards for 10 metres
2163	Southall Avenue	West	(on the traffic island) From a prolongation of the property boundary of Nos.65 & 67 Southall Avenue southwards for 11 metres
2164	Southall Avenue	East	From the boundary Nos.96 & 98 Southall Avenue northwards for 21 metres

Part 6.1 - Disabled Badge Holders Parking At Any Time

Delete the following items:


Item No.	Road Name	Side	Description
603	Southall Avenue	East	East side from a point 9 metres north of the boundary wall between Nos.28 & 30 Southall Avenue northwards for 5.5 metres (outside No.32)
604	Southall Avenue	East	From the boundary wall between Nos.44 & 46 Southall Avenue southwards for 5.5 metres (outside No.44)

605	Southall Avenue	West	From a point 1 metre south of the northern building line of No.68 Southall Avenue southwards for 6.6 metres (outside No.68)
606	Southall Avenue	West	From a point 5 metres from the southern end of Southall Avenue northwards for 5.5 metres (opposite No.86)
607	Southall Avenue	South	From a point 1 metre west of the eastern building line of No.75 Southall Avenue eastwards for 6.6 metres (opposite No.75)
