ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove Various Controlled Parking Zones Consolidation Order 2024
Amendment Order No.4 2025 (TRO-36-2024)**

Brighton & Hove City Council (“the Council”) in exercise of its powers under Sections 1(1), 2(1) and (2), 4, 45, 46, 49, 53, 124(1)(c) & (d) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the 1984 Act”) as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as the Brighton & Hove Various Controlled Parking Zones Consolidation Order 2024 Amendment Order No.4 2025 and shall come into operation on the 14th day of April 2024.
2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2024 is amended as follows:


