ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove Various Controlled Parking Zones Consolidation Order 2024
Amendment Order No.7 2025 (TRO-5c-2024)**

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) and (2), 4, 45, 46, 49, 53, 124 (1) (c) & (d) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as the Brighton & Hove Various Controlled Parking Zones Consolidation Order 2024 Amendment Order No. 7 2025 and shall come into operation on the 7th day of June 2025.

2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2024 is amended as follows:

ARTICLE AMENDMENTS

PART 1 GENERAL

Delete the following definition:

"Motor Vehicle" means a mechanically propelled vehicle (without trailer) with 3 or more wheels not being an Invalid Carriage or a Motorcycle and which:

- a. has an unladen weight not exceeding 2540 Kilograms.
- b. does not exceed 2.25 metres in overall height.
- c. does not exceed 6.00 metres in overall length or in the case of a Car Club Vehicle 5.00 metres in overall length.

Add in the following definitions:

"Authorised Person" means an employee or agent of the Council authorised to exercise all or any of the functions of the Council under this Order;

"Bus Stop" means an area of carriageway bounded by the broken yellow lines comprising the road marking shown in diagram 1025.1 in schedule 7 to the Traffic Signs Regulations and General Directions 2016 (as amended) and on which is marked the words "bus stop"

"Emergency Service Vehicle" means a vehicle operated by the police, fire & rescue service or ambulance service;

"Footway" means that part of the Highway over which the public have a right of way for the passage of pedestrians;

“Motor Vehicle” means a mechanically propelled vehicle intended or adapted for use on roads subject to Section 20 Chronically Sick and Disabled Persons Act 1970;

PROVIDED for the purposes of issuing of permits it is restricted to motor vehicles (without trailer) with 3 or more wheels not being an Invalid Carriage or a Motorcycle and which;

- a. has an unladen weight not exceeding 2540 Kilograms.
- b. does not exceed 2.25 metres in overall height.
- c. does not exceed 6.00 metres in overall length or in the case of a Car Club Vehicle 5.00 metres in overall length.

“Private Hire Vehicle” has the same meaning as in Section 80 of the Local Government (Miscellaneous Provisions) Act 1976;

“Red Route” means a road or parts of a Road listed in Schedule 1 Part 17 (Red Routes) comprising the whole width of Highway (for avoidance of doubt including the footway) except where only one side of a road is specified in Schedule 1 Part 22 where it shall comprise the highway from its edge to the centre of the carriageway;

“Road marking” means a traffic sign consisting of a line or mark or legend on the surface on the road of a size, colour and type prescribed or authorised under Section 64 of the Road Traffic Regulation Act 1984;

“Traffic Signs Regulation and General Directions” means the Traffic Signs Regulation and General Directions 2016 as amended from time to time;

“Taxi” has the same meaning as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;

Delete the following:

“Prescribed Hours” means those days and hours specified in:

Schedule 1 Parts 1 to 3 (inclusive) for each of the Controlled Parking Zones referred to therein during which parking, waiting, stopping or loading/unloading is restricted in the Restricted Roads or parts thereof described therein subject to the provisions of this order,

Schedule 1 Parts 4 to 19 (inclusive) for each of the Controlled Parking Zones referred to therein during which vehicles or classes of vehicles may park, wait, stop or load/unload in the Parking Places described therein subject to the provisions of this Order,

Replace with:

“Prescribed Hours” means those days and hours specified in:

Schedule 1 Parts 1 to 3 (inclusive) and Part 22 for each of the Controlled Parking Zones referred to therein during which parking, waiting, stopping or loading/unloading is restricted in the Restricted Roads, Red Routes or parts thereof described therein subject to the provisions of this order,

Schedule 1 Parts 4 to 19 (inclusive) and Part 22 for each of the Controlled Parking Zones referred to therein during which vehicles or classes of vehicles may park, wait, stop or load/unload in the Parking Places described therein subject to the provisions of this Order,

PART 2 WAITING OF VEHICLES

Add in new title before paragraph 1 as follows:

Part 1.1 General

Delete the following:

1. Subject to the provisions of Article 2 of this Part no person shall except upon the direction or with the permission of a Civil Enforcement Officer or Police Constable in uniform or person authorised by the Council cause or permit any vehicle to park, stop or wait in any Restricted Road during the Prescribed Hours.

Add in the following:

1. Subject to the provisions of Article 2 of this Part no person shall except upon the direction or with the permission of a Civil Enforcement Officer or Police Constable in uniform or person authorised by the Council cause or permit any vehicle to park, stop or wait in any Restricted Road or Red Route during the Prescribed Hours.

PROVIDED that in the case of the roads detailed in Schedule 1 Part 22 Red Routes, Part 1.2 of this order shall prevail.

After paragraph 3 add in new subtitle and articles as follows:

Part 1.2 Red Routes

1. Subject to the provisions of Article 2 of this Order no person shall except upon the direction or with the permission of a Civil Enforcement Officer Police Constable in uniform or person authorised by the Council cause or permit any vehicle to park, stop or wait in those lengths of roads as described in Schedule 1 Part 22 Red Routes.

2 Nothing in Article 1 of this Part shall prevent any person from causing or permitting a vehicle to stop or wait within a Red Route on the lengths detailed in Schedule 1 Part 22

- (1) To enable a vehicle to be parked in the course of an emergency by Emergency Service Vehicles.

- (2) To enable a vehicle (if it cannot reasonably be used for the same purpose in any other road) to be used in connection with any of the following operations in an emergency: building works; the removal of any obstruction to traffic; the maintenance, improvement or reconstruction of the road; the laying, erection, alteration or repair in or adjacent to the road by an Undertaker of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus.
- (3) To enable a vehicle in the service of a local authority for the purpose of collecting refuse and/ or recycling from premises adjacent to restricted section of road.
- (4) To enable a vehicle which is loading or unloading scaffolding or glazing to a premises immediately adjoining a restricted section of road and if that vehicle cannot reasonably be used for the same purpose in any other road.
- (5) To enable a blue badge holder to board or alight from the vehicle provided that the vehicle cannot reasonably be used for the same purpose in any other road.
- (6) To enable Taxis and Private Hire Vehicles to enable their passengers to board or alight from the vehicle provided that the vehicle cannot reasonably be used for the same purpose in any other road.
- (7) For a vehicle to use the designated bays within the length of Red Route as described in Schedule 1 Part 22 as follows Shared Parking Bays (Paid & Permit) Part 22.2, Paid Parking Bays Part 22.3, Disabled Bays Part 22.4, Motorcycle Bays Part 22.5 and Loading Bay Part 22.6, Taxi Ranks Part 22.7 and in accordance with Part 3 of this Order.
- (8) For a bus to stop at a bus stop for as long as may be required to enable passengers to board or alight

PART 3 – PARKING PLACES

Delete the following:

1. Each length of road identified in Schedule 1 Parts 4 to 17 (inclusive) and 19 of that Schedule is hereby authorised to be used as a Parking Place during the Prescribed Hours for vehicles or classes of vehicles as set out below and any reference herein to a numbered Part of that Schedule shall be taken as a reference to that same numbered Part that appears in any or all of the Controlled Parking Zones identified in that Schedule.

Replace with:

- I. Each length of road identified in Schedule 1 Parts 4 to 17 (inclusive), 19 and 22.2 to 22.7 (inclusive) to of that Schedule is hereby authorised to be used as

a Parking Place during the Prescribed Hours for vehicles or classes of vehicles as set out below and any reference herein to a numbered Part of that Schedule shall be taken as a reference to that same numbered Part that appears in any or all of the Controlled Parking Zones identified in that Schedule.

Delete following:

(2) Shared Permit Shared Permit or Paid Parking Places (Schedule 1 Part 5) by use by vehicles in accordance with parts 4 & 5 or this Order

Replace with:

(2) Shared Permit or Paid Parking Places (Schedule 1 Part 5 and Part 22.2) by use by vehicles in accordance with parts 4 & 5 or this Order

Delete following:

(3) Exclusive Paid Parking Places (Schedule 1 Part 6) for the use by vehicles in accordance with Part 5 of this Order.

Replace with:

(3) Exclusive Paid Parking Places (Schedule 1 Part 6 and 22.3) for the use by vehicles in accordance with Part 5 of this Order.

Delete following:

(6) (a) Schedule 1 Parts 9.1, 9.3, 9.7 and 9.10 for use by vehicles displaying a valid Disabled Person's Badge only.

Replace with:

(6) (a) Schedule 1 Parts 9.1, 9.3, 9.7, 9.10 and 22.4 for use by vehicles displaying a valid Disabled Person's Badge only.

Delete following:

(8) Motorcycle Parking Places (Schedule 1 Part 11) for use by Motorcycles only.

Replace with:

(8) Motorcycle Parking Places (Schedule 1 Part 11 and 22.5) for use by Motorcycles only.

Delete the following Paragraph (9):

(9) Loading Bays:

(a) Schedule 1 Parts 12.1, 12.7, 12.8, 12.9, 12.10, 12.11, 12.12, 12.19, 12.20, 12.21, 12.22, 12.25, 12.27 & 12.29 inclusive for use by vehicles for the purpose of delivering or collecting Goods including loading or unloading the vehicle only.

Replace with:

(9) Loading Bays:

- (a) Schedule 1 Parts 12.1, 12.7, 12.8, 12.9, 12.10, 12.11, 12.12, 12.19, 12.20, 12.21, 12.22, 12.25, 12.27, 12.29 & 22.6 inclusive for use by vehicles for the purpose of delivering or collecting Goods including loading or unloading the vehicle only.

Delete the following Paragraph (10):

- (10) Taxi Ranks (Schedule 1 Part 13.1 & 13.3) for use by Licensed Taxis which are available for hire only.

Replace with:

- (11) Taxi Ranks (Schedule 1 Part 13.1, 13.3 & 22.7) for use by Licensed Taxis which are available for hire only.

Delete the following:

3. Without prejudice to the foregoing provisions of this Part any vehicle may wait in a Parking Place during the Prescribed Hours other than a Parking Place or part thereof the use of which has been suspended if it cannot conveniently be used for such purposes in any other road if:

- (1) in the case of Permit Parking Places, Paid Parking Places and Limited Waiting Parking Places only the vehicle is being used for any purpose or eventuality specified in Part 2 Article 2 (1) (4) (5) (7) and (8) of this Order which said Articles shall be construed as if "Parking Place" was substituted for "Restricted Road" wherever the latter expression occurs or
- (2) in the case of all other Parking Places described in Article 1 of this Part the vehicle is being used for any purpose or eventuality specified in Part 2 Article 2 (4) (5) and (7) of this Order which said Articles shall be construed as if "Parking Place" was substituted for "Restricted Road" wherever the latter expression occurs.

Replace with :

3. Without prejudice to the foregoing provisions of this Part any vehicle may wait in a Parking Place during the Prescribed Hours other than a Parking Place or part thereof the use of which has been suspended if it cannot conveniently be used for such purposes in any other road if:

- (1) in the case of Permit Parking Places, Paid Parking Places and Limited Waiting Parking Places only the vehicle is being used for any purpose or eventuality specified in Part 2 Article 2 (1) (4) (5) (7) and (8) of this Order which said Articles shall be construed as if "Parking Place" was substituted for "Restricted Road" or "Red Route" wherever the latter expression occurs or
- (2) in the case of all other Parking Places described in Article 1 of this Part the vehicle is being used for any purpose or eventuality specified in Part 2

Article 2 (4) (5) and (7) of this Order which said Articles shall be construed as if "Parking Place" was substituted for "Restricted Road" or "Red Route" wherever the latter expression occurs.

PART 5- PAID PARKING PLACES

Delete the following:

1. Each length of road identified in Schedule 1 Parts 5 and 6 are hereby authorised to be used as a Paid Parking Place during the Prescribed Hours for vehicles and or classes of vehicles as described herein and any reference herein to a numbered Part of that Schedule shall be taken as a reference to that same numbered Part that appears in any or all of the Controlled Parking Zones identified in that Schedule.

Replace with the following:

1. Each length of road identified in Schedule 1 Parts 5, 6 ,22.2 and 22.3 are hereby authorised to be used as a Paid Parking Place during the Prescribed Hours for vehicles and or classes of vehicles as described herein and any reference herein to a numbered Part of that Schedule shall be taken as a reference to that same numbered Part that appears in any or all of the Controlled Parking Zones identified in that Schedule.

Delete the following:

3. Each Paid Parking Place identified in Schedule 1 Parts 5 and 6 may be used subject to the provisions of this Part by vehicles during the Prescribed Hours on payment of such charges as are specified in Schedule 2 Part 2 provided that:

(1) those vehicles that display a valid Resident's, Business, Carer's, Residents' Visitor, Hotel Guest or School Permit may be left with exemption from payment of the charges and any limits on time in any of the Parking Places which are in the CPZ for which the Permit has been issued and specified in Schedule 1 Part 5 only.

(2) those vehicles that display a valid Trader's Permit may be left in any of the Parking Places specified in Schedule 1 Parts 5 and 6 with exemption from payment of the charges and any limits on time provided that the vehicle is being used for the purposes for which the Permit has been issued.

(3) those vehicles that display in the Relevant Position a valid Disabled Person's Badge may be left in any of the Parking Places specified in Schedule 1 Parts 5 and 6 with exemption from payment of the charges and any limits on time provided that the badge is being used in accordance with the provisions of the Blue Badge Scheme.

(4) those vehicles that display a valid Professional Carer's Permit may be left in any of the Parking Places specified in Schedule 1 Parts 5 and 6 with exemption from payment of the charges for a maximum period of two hours or such other period

authorised by the Council provided that the vehicle is being used for the purposes for which the permit has been issued.

Replace with the following:

3. Each Paid Parking Place identified in Schedule 1 Parts 5, 6, 22.2 and 22.3 may be used subject to the provisions of this Part by vehicles during the Prescribed Hours on payment of such charges as are specified in Schedule 2 Part 2 provided that:

(1) those vehicles that display a valid Resident's, Business, Carer's, Residents' Visitor, Hotel Guest or School Permit may be left with exemption from payment of the charges and any limits on time in any of the Parking Places which are in the CPZ for which the Permit has been issued and specified in Schedule 1 Part 5 and 22.2 only.

(2) those vehicles that display a valid Trader's Permit may be left in any of the Parking Places specified in Schedule 1 Parts 5, 6, 22.2 & 22.3 with exemption from payment of the charges and any limits on time provided that the vehicle is being used for the purposes for which the Permit has been issued.

(3) those vehicles that display in the Relevant Position a valid Disabled Person's Badge may be left in any of the Parking Places specified in Schedule 1 Parts 5, 6, 22.2 and 22.3 with exemption from payment of the charges and any limits on time provided that the badge is being used in accordance with the provisions of the Blue Badge Scheme.

(4) those vehicles that display a valid Professional Carer's Permit may be left in any of the Parking Places specified in Schedule 1 Parts 5, 6, 22.2 and 22.3 with exemption from payment of the charges for a maximum period of two hours or such other period authorised by the Council provided that the vehicle is being used for the purposes for which the permit has been issued.

Delete the following:

4. The Driver of a vehicle shall not permit it to wait in a Paid Parking Place for longer than any maximum period permitted for waiting in that Parking Place as specified in Schedule 1 Parts 5 and 6 and upon leaving that Parking Place the vehicle shall not be returned to the same Parking Place before the elapse of any no return period specified in that Schedule and shown on the Traffic Sign subject to the provisions of Article 3 of this Part.

Replace with the following:

4. The Driver of a vehicle shall not permit it to wait in a Paid Parking Place for longer than any maximum period permitted for waiting in that Parking Place as specified in Schedule 1 Parts 5, 6, 22.2 and 22.3 and upon leaving that Parking Place the vehicle shall not be returned to the same Parking Place before the elapse of any no return period specified in that Schedule and shown on the Traffic Sign subject to the provisions of Article 3 of this Part.

PART 7 – CONTRAVENTIONS

Penalty Charge Notices

Delete the following:

- I. If a vehicle is left in any Restricted Road or Parking Place identified in Schedule 1 to this Order during the Prescribed Hours without complying with the requirements of this Order a contravention shall have occurred and a Penalty Charge shall be payable. A Penalty Charge Notice showing the information required by the Traffic Management Act 2004 and subsequent legislation may then be issued by a Civil Enforcement Officer or the Council, as the enforcement authority for the purposes of the 2004 Act, in accordance with the requirements of that Act and the Penalty Charge shall be paid in accordance with the payment instructions on the Penalty Charge Notice.

Replace with the following:

- I. If a vehicle is left in any Restricted Road, Red Route or Parking Place identified in Schedule 1 to this Order during the Prescribed Hours without complying with the requirements of this Order a contravention shall have occurred and a Penalty Charge shall be payable. A Penalty Charge Notice showing the information required by the Traffic Management Act 2004 and subsequent legislation may then be issued by a Civil Enforcement Officer or the Council, as the enforcement authority for the purposes of the 2004 Act, in accordance with the requirements of that Act and the Penalty Charge shall be paid in accordance with the payment instructions on the Penalty Charge Notice.

PART 8 - HIERARCHY OF RESTRICTIONS

Delete the following:

1. For each of the Controlled Parking Zones identified therein the waiting restrictions imposed by Schedule 1 Part 1 in relation to any road do not apply to any length of that road which is subject to parking restrictions specified in Schedule 1 Parts 4, 5 and 6 (inclusive). The restrictions in Schedule 1 Parts 1, 4, 5 and 6 (inclusive) shall not apply to any length of a road specified in Schedule 1 Parts 7 to 19 (inclusive)

Replace with the following:

1. For each of the Controlled Parking Zones identified therein the waiting restrictions imposed by Schedule 1 Part 1 in relation to any road do not apply to any length of that road which is subject to parking restrictions specified in Schedule 1 Parts 4, 5 and 6 (inclusive). The restrictions in Schedule 1 Parts 1, 4, 5 and 6 (inclusive) shall not apply to any length of a road specified in Schedule 1 Parts 7 to 19 (inclusive)

Provided that the roads do not form part of a Red Route as detailed in Schedule 1 Part 22.1, in which case the restrictions imposed by Schedule 1 Part 22.2 do not apply to any length of that road which is subject to parking restrictions specified in Schedule 1 Part 22.2, 22.3, 22.4, 22.5, 22.6 and 22.7
