

**BRIGHTON & HOVE CITY COUNCIL  
ROAD TRAFFIC REGULATION ACT 1984**

**The Brighton & Hove Various Controlled Parking Zones Consolidation  
Order 2008 Amendment Order No.1 2009  
(Pedal Cycle Parking Places)**

Brighton & Hove City Council (hereinafter referred to as "the Council"), in exercise of their powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the Act"), as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers hereby make the following Order:-

**1. General**

This Order which may be cited as "The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2008 Amendment Order No.1 2009 (Pedal Cycle Parking Places)" amends the provisions of "The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2008 ("the 2008 Order") as follows and comes into operation on the 8<sup>th</sup> day of March 2009.

**2. Article Amendments**

The 2008 Order is amended as follows:-

**Part 1 – General**

In Article 3:

After the expression "**Pedal Cycle**" add the new expression "**Pedal Cycle Parking Place**" and the meaning "means a length of road indicated by Traffic Signs authorising it to be used for the leaving of a Pedal Cycle in accordance with the provisions of this Order;

For the expression "**Prescribed Hours**", at the end of the second unnumbered paragraph after the word "Order" add the word "and" and after that paragraph add a new third paragraph as below:

"Schedule 1 Part 19 for each of the Controlled Parking Zones referred to therein during which Pedal Cycles may stand in the Pedal Cycle Parking Places described therein subject to the provisions of this Order;"

**Part 3 – Parking Places**

After Article 10 add the following new Article 11:

**Pedal Cycle Parking Places**

11. Each length of road identified in Schedule 1 to which Part 19 of that Schedule applies for any of the Controlled Parking Zones referred to therein is hereby authorized to be used by Pedal Cycles only provided that:

- (1) the limits of each Pedal Cycle Parking Place shall be indicated by a traffic sign only and not road markings with the authority of the Secretary of State for Transport in exercise of his powers under Sections 64 and 65 of the Act and any Pedal Cycle left in a Pedal Cycle Parking Place shall only be parked against a stand provided therein.
- (2) the provisions of Articles 3 (2), 4 and 10 of this Part shall also apply to Pedal Cycle Parking Places as if they were a Parking Place.



- (3) the provisions of Parts 6 and 7 of this Order shall apply to Pedal Cycle Parking Places and any reference therein to a "Parking Place" shall also mean a "Pedal Cycle Parking Place".

### Part 8 - Hierarchy of Restrictions

At the end of the final sentence, after the word "(inclusive)" add "and Part 19."

### Part 10 - Index of Schedule I

Below Part 18.1 add the following new Part to the Index:

19	Pedal Cycle Parking Places	
19.1	At Any Time	M

### 3. Schedule I Amendments

The 2008 Order is amended as follows:-

#### 3.1 Part 9.1 Disabled Badge Holders Parking At Any Time

For Controlled Parking Zone M only, delete the existing description for Item No.9 and replace it with the following: "From a point 146 metres north of the northern kerbline of Brunswick Terrace northwards for a distance of 6.6 metres."


For Controlled Parking Zone M only, delete the existing description for Item No.11 and replace it with the following: "From a point 146 metres north of the northern kerbline of Brunswick Terrace northwards for a distance of 6.6 metres."

#### 3.2 Add to Schedule I for Controlled Parking Zone M only a new Part as follows: Part 19.1

##### Pedal Cycle Parking Places At Any Time

Item No.	Street Name	Side of Road	Description	CPZ
1	Brunswick Square	West (Eastern Arm)	from a point 135.7 metres north of the northern kerbline of Brunswick Terrace northwards for a distance of 10.3 metres.	M
2	Brunswick Square	East (Western Arm)	from a point 135.7 metres north of the northern kerbline of Brunswick Terrace northwards for a distance of 10.3 metres.	M
