**BRIGHTON & HOVE VARIOUS CONTROLLED PARKING ZONES
CONSOLIDATION ORDER 2008 AMENDMENT ORDER No.3 2009**

Brighton & Hove City Council (hereinafter referred to as "the Council"), in exercise of their powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the Act"), as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the Act, hereby make the following Order:-

1. General

This Order which may be cited as the Brighton & Hove Various Controlled Parking Zones Consolidation Order 2008 Amendment Order No.3 2009 amends the provisions of the Brighton & Hove Various Controlled Parking Zones Consolidation Order 2008 and comes into operation on the 17th day of *August* 2009.

2. Amendments

Schedule 1 – Controlled Parking Zone Z

Part 5.18

Shared Permit Holders and High Tariff Short Term Pay & Display parking (for a period of up to 2 hours no return within 4 hours) from Monday to Sunday between 9am to 8pm inclusive

Insert new Item 2 as follows:

Item No.	Street Name	Side of Road	Description	CPZ
2	Black Lion Street	west	From a point 16.8 metres north of the northern kerbline of Kings Road northwards for a distance of 22.6 metres	Z

Delete existing description for Item 8 "Middle Street" and replace with:
"From a point 16.4 metres north of the northern kerbline of Kings Road northwards for a distance of 13.3 metres"

Part 9.1

Disabled Badge Holders Parking At Any Time

Delete existing description for Item 12 "Middle Street" and replace with:
"From a point 9.8 metres north of the northern kerbline of Kings Road northwards for a distance of 6.6 metres"

Part 11.1

Motorcycles only At Any Time

Insert new Item 5 as follows:

Item No.	Street Name	Side of Road	Description	CPZ
5	Black Lion Street	west	From a point 39.4 metres north of the northern kerbline of Kings Road northwards for a distance of 6 metres	Z
