ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove (Bedford Place and Tichborne Street, Brighton)
(Pedal Cycle Parking Places) Order 2009**

Brighton & Hove City Council (hereinafter referred to as "the Council"), in exercise of their powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the Act") as amended and by Part 6 of the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers hereby make the following Order:-

1. GENERAL

- 1.1 This Order may be cited as the "Brighton & Hove (Bedford Place and Tichborne Street, Brighton) (Pedal Cycle Parking Place) Order 2009" and shall come into operation on the *23rd June* 2009.

2. INTERPRETATION

- 2.1 In this Order, except where the context otherwise requires, the following expressions have the meanings assigned to them:

"the Act" means the Road Traffic Regulation Act 1984 as amended;

"Hours of Operation" means the hours identified in this Order in respect of Schedule 2 of this order;

"Pedal Cycle" for the purposes of this Order means a pedal bicycle, pedal tricycle or a pedal cycle having four or more wheels, not being in any case capable of being mechanically propelled;

"Pedal Cycle Parking Place" means an area on a highway designated as such by this Order;

3 PEDAL CYCLE PARKING PLACES

3.1 DESIGNATION

Each of the parts of the highway identified as a Pedal Cycle Parking Place in Schedule 2 of this experimental Order is hereby designated as a Pedal Cycle Parking Place.

3.2 USE

Subject to the exemptions in Schedule 1 to this Order a Pedal Cycle Parking Place may only be used for parking a Pedal Cycle in accordance with this Order

3.3 MANNER OF PARKING

Any Pedal Cycle left in a Pedal Cycle Parking Place shall only be parked against a stand provided in that Pedal Cycle Parking Place.

3.4 DAYS AND HOURS OF OPERATION

The hours of operation of each Pedal Cycle Parking Place are 24 hours every day.

3.5 PROHIBITION

It is prohibited to use a Pedal Cycle Parking Place otherwise than in accordance with this Order.

4. When this Order comes into operation, it will amend other orders as specified in Schedule 3 to this order.

Schedule 1
Exemptions

- (i) Emergency Service Vehicles.
- (ii) A vehicle which cannot reasonably be used for the same purpose in any other road, where that purpose is use in connection with any building operation, demolition or excavation, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of Bedford Place or Tichborne Street, or the laying, erection, alteration or repair in or adjacent to Bedford Place or Tichborne Street of any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984, or for the purposes of delivering or collecting postal packets as defined in section 87 of the Post Office Act 1953 or providing maintaining or replacing traffic signs or with the written consent of the council for charitable or public social events.
- (iii) A vehicle parked under the direction or with the permission of a Police Officer in uniform.

Schedule 2
Pedal Cycle Parking Places At Any Time

Bedford Place

East side – From a point 5 metres south of the southern kerbline of Western Road southwards for 7.8 metres.

Tichborne Street

East side - From a point 7.3 metres south of the southern kerbline of North Road southwards for 11.4 metres.

Delete the existing "Description" for Item 1 (Bedford Place) and replace with
"From a point 16.8 metres south of the southern kerbline of Western Road
southwards to a point 1 metre north of the southern property boundary of
No. 21a Bedford Place".

Part 11.1 Motorcycles only At Any Time

Delete the existing "Description" for Item 3 (Bedford Place) and replace with
"From a point 12.8 metres south of the southern kerbline of Western Road
southwards for 4 metres".
