ROAD TRAFFIC REGULATION ACT 1984**

**BRIGHTON & HOVE VARIOUS CONTROLLED PARKING ZONES
CONSOLIDATION ORDER 2008 AMENDMENT ORDER No.4 2010**

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers hereby make the above named Order.

The provisions of this Order will come into operation on the *4th* day of *May* 2010 and amend the Brighton & Hove Various Controlled Parking Zones Consolidation Order 2008 as follows:

PART 4.1 – General

Permit Particulars

In Article 7 (v):

Delete the words “and also the name of the Hotel”

Delete the words “in the sections marked and provided for those purposes.” and substitute “in the section marked and provided for that purpose.”

PART 4.2 – Types of Permit

Resident’s Visitor Permits

In Article 26 after the words “being applied for” add the words “subject to the provisions of Article 27 (ii) of this Part.”

In Article 27:

After “Z” add the words “provided that:”

Delete the existing words “PROVIDED that” and substitute “(i)”


After (i) insert the following:

- (ii) the Council may at its absolute discretion issue Resident’s Visitor Permits to an association recognised by the Council as representing the owners or occupiers of properties in Brunswick Place (numbers 1 to 8 inclusive only), Brunswick Square and Brunswick Terrace, such permits to be used only to enable contractors engaged in the painting of the frontage of those properties identified by the Hove Borough Council Act 1976 to park vehicles being used for that purpose in Permit and Shared Permit or Pay & Display Parking Places in CPZ “M”.
- (iii) for the purposes of Articles 26 and 29 of this Part the expression “Resident” shall also mean an association representing the owners or occupiers of properties in Brunswick Place (numbers 1 to 8 inclusive only), Brunswick Square and Brunswick Terrace.

In Article 29 after the words “under Article 27 of this Part” insert the words “and for the purposes of this Article the expression “Resident” shall include an association as described in part (ii) of that Article.”
