BRIGHTON & HOVE VARIOUS CONTROLLED PARKING ZONES CONSOLIDATION ORDER 2008 AMENDMENT ORDER No.2 2011

Brighton & Hove City Council in exercise of its powers under Sections I, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the above named Order.

The provisions of this Order will come into operation on the 26th day of March 2011 and amend the Brighton & Hove Various Controlled Parking Zones Consolidation Order 2008 as follows:

ARTICLE AMENDMENTS:

PART I - GENERAL

In Article 3:

For the expression "Electric Vehicle" add the words "including a Motorcycle" after the words "means a vehicle"

After the expression "Permit Parking Place" insert the following new expression and meaning:

"Plug in Hybrid Vehicle" means a vehicle including a Motorcycle where the motive power can be provided either by an internal combustion engine or by an electric motor powered by an electrical storage battery which can be recharged from an external source of electricity.

For the expression "Prescribed Hours" in the paragraph commencing "Schedule I Part 20" insert the words "or Plug in Hybrid Vehicles" after the words "during which Electric Vehicles"

PART 3 - PARKING PLACES

In Article I (16) insert the words "or Plug in Hybrid Vehicles" after the words "for use by Electric Vehicles"

PART 4 – PARKING PERMITS

PART 4.1 - General

Delete Article 3 (vi) "in the case of an Electric Vehicle Permit no charge shall be payable if the applicant is already the holder of a Resident, Business or Trader Permit issued by the Council in respect of the same vehicle."

PART 4.2 – Types of Permit

Electric Vehicle Permits

In Article 36 add the words "or Plug in Hybrid Vehicle" after the words "falls within the definition of Electric Vehicle"

In Article 37 add the words "or Plug in Hybrid Vehicle" after the words "to park the Electric Vehicle"

Item 26 (Electric Vehicles):

For each of the Controlled Parking Zones delete "20" (£) and substitute the word "Free"
