BRIGHTON & HOVE (WAITING & LOADING/UNLOADING RESTRICTIONS AND PARKING PLACES) CONSOLIDATION ORDER 2008 AMENDMENT ORDER No.1 2010

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers hereby make the above named Order.

The provisions of this Order will come into operation on the day of April 2010 and amend the Brighton & Hove (Waiting & Loading/Unloading Restrictions and Parking Places) Consolidation Order 2008 as follows:-

ARTICLE AMENDMENTS

Part I - General

After the existing expression "Civil Enforcement Officer" insert a new expression and meaning as follows:

"Cycle Lane" means a part of a highway indicated by Traffic Signs authorizing it to be used by Pedal Cycles only in accordance with the provisions of this Order;

Part 7 - Cycle Lanes

In Article I delete the words "Schedule 15" and substitute "Schedule I Part 15".

Add new article as follows:

4. Nothing in Article I of this Part shall render it unlawful for a person to cause or permit a vehicle to enter a Cycle Lane for the purpose of accessing or leaving premises adjacent to that Cycle Lane by means of a driveway provided for that purpose.

Amend existing item number 6: Old London Road as follows:- delete "From a point 60.2 metres north of the northern kerbline of Old Patcham Mews northwards for a distance of 43.6 metres" and substitute "From a point opposite the northern property boundary of No. 138 Old London Road southwards for 7.6 metres"

Add new items 12 and 13 as follows:
