Amend existing item Ref. no.5 Lewes Road (south-east side): delete the description "From a point I metre north-east of the north-eastern kerbline of Franklin Road north-east for 18 metres" and substitute "From a point 10.5 metres north-east of the north-eastern kerbline of Franklin Road north-eastwards for 8.5 metres"
