**BRIGHTON & HOVE (WAITING & LOADING/UNLOADING RESTRICTIONS AND
PARKING PLACES) CONSOLIDATION ORDER 2008 AMENDMENT ORDER No.6 2010
(LEWES ROAD/FRANKLIN ROAD)**

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the above named Order.

The provisions of this Order will come into operation on the *11th* day of *October* 2010 and amend the Brighton & Hove (Waiting & Loading/Unloading Restrictions and Parking Places) Consolidation Order 2008 as follows:-

SCHEDULE 1 AMENDMENTS:

PART 1.1 No Waiting At Any Time

Amend existing item Ref. no.876 Franklin Road – Brighton (south-west side): delete the description "From the south-eastern kerbline of Lewes Road south-eastwards for a distance of 21.3 metres" and substitute "From the eastern kerbline of Lewes Road south-eastwards for a distance of 10 metres"

PART 11.1 Loading bay At Any Time

Amend existing item Ref. no.5 Lewes Road (south-east side): delete the description "From a point 1 metre north-east of the north-eastern kerbline of Franklin Road north-east for 18 metres" and substitute "From a point 10.5 metres north-east of the north-eastern kerbline of Franklin Road north-eastwards for 8.5 metres"

After Part 11.7 insert the following new Part in the Schedule:

PART 11.8 Loading bay 7am – 6pm every day

Ref no.	Road Name	Side	Description
1	Franklin Road - Brighton	South-west	From a point 10 metres south-east of the eastern kerbline of Lewes Road south-eastwards for 14.8 metres
