**BRIGHTON & HOVE (WAITING & LOADING/UNLOADING
RESTRICTIONS AND PARKING PLACES) CONSOLIDATION ORDER 2008
AMENDMENT ORDER No.10 2010
(PEDAL CYCLE PARKING PLACES)**

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the above named Order.

The provisions of this Order will come into operation on the *31st* day of *December* 2010 and amend the Brighton & Hove (Waiting & Loading/Unloading Restrictions and Parking Places) Consolidation Order 2008 as follows:

ARTICLE AMENDMENTS:

PART 3 – PARKING PLACES
