# BRIGHTON & HOVE CITY COUNCIL ROAD TRAFFIC REGULATION ACT 1984

# BRIGHTON & HOVE (WAITING & LOADING/UNLOADING RESTRICTIONS AND PARKING PLACES) CONSOLIDATION ORDER 2008 AMENDMENT ORDER No.12 2010

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the above named Order.

The provisions of this Order will come into operation on the 10<sup>th</sup> day of January 2011 and amend the Brighton & Hove (Waiting & Loading/Unloading Restrictions and Parking Places) Consolidation Order 2008 as follows:

#### **ARTICLE AMENDMENTS:**

#### PART I - GENERAL

In Article 3:

For the expression "Prescribed Hours" in the paragraph commencing "Schedule I Parts 5 to 14 (inclusive)" after the word "(inclusive)" add the words "and Part 18"

#### PART 3 - PARKING PLACES

In Article I after the word "(inclusive)" add the words "and Part 18"

After existing Article I (10) add the following:

(12) Loading Bays and Limited Waiting Parking Places (Schedule 1 Part 18) for use by vehicles for the purpose of delivering or collecting Goods including loading or unloading the vehicle or by vehicles including motorcycles with or without side-car waiting for no longer than the period specified in the Schedule with no return allowed before the expiration of the period specified in the Schedule from the time that the same vehicle has been moved from such a Parking Place.

After existing Part 5.25 add the following new Part to the Index:
