

**BRIGHTON & HOVE CITY COUNCIL
ROAD TRAFFIC REGULATION ACT 1984**

**BRIGHTON & HOVE SEAFRONT (VARIOUS RESTRICTIONS)
CONSOLIDATION ORDER 2008 AMENDMENT ORDER No.4 2009**

Brighton & Hove City Council, in exercise of their powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984, as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers hereby make the above named Order.

The provisions of this Order will come into operation on the *19th* day of *September* 2009 and amend the Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2008 as follows:

Part 5 – Pay & Display Parking Places

Delete existing Article 8 (3) and replace with the following:

8.

- (3) A Pay & Display Ticket issued on payment of the charge referred to in the preceding parts of this Article shall be valid for a Pay & Display Parking Place if and so long as the following conditions are satisfied:
 - (a) the ticket is exhibited on the vehicle in the following manner throughout the period of parking paid for:
 - (i) in the case of a vehicle which is fitted with a transparent windscreen by either sticking the Pay & Display Ticket on the inside surface of the windscreen on the nearside facing forwards or by placing it on the dashboard on the nearside facing upwards so that in either case the expiry details are clearly visible and readable from the front or nearside of the vehicle or
 - (ii) in the case of a vehicle which is not fitted with a transparent windscreen by affixing the Pay & Display Ticket securely on the dashboard on the nearside facing upwards so that the expiry details are clearly visible and readable from the front or nearside of the vehicle.
 - (b) the period paid for by the Initial Charge has not expired as indicated by the expiry date and time printed and displayed on the ticket.
 - (c) the payment made for the Initial Charge is correct for the Tariff Type applicable to the Parking Place in which the vehicle has been left.


Part 6 – Pay & Display Coach Parking Places

Delete existing Article 7 (3) and replace with the following:

7.

- (3) A Pay & Display Ticket issued on payment of the charge referred to in the preceding parts of this Article shall be valid for a Pay & Display Parking Place if and so long as the following conditions are satisfied:
- (a) the ticket is exhibited on the vehicle in the following manner throughout the period of parking paid for:
- (i) in the case of a vehicle which is fitted with a transparent windscreen by either sticking the Pay & Display Ticket on the inside surface of the windscreen on the nearside facing forwards or by placing it on the dashboard on the nearside facing upwards so that in either case the expiry details are clearly visible and readable from the front or nearside of the vehicle or
- (ii) in the case of a vehicle which is not fitted with a transparent windscreen by affixing the Pay & Display Ticket securely on the dashboard on the nearside facing upwards so that the expiry details are clearly visible and readable from the front or nearside of the vehicle.
- (b) the period paid for by the Initial Charge has not expired as indicated by the expiry date and time printed and displayed on the ticket.
