**BRIGHTON & HOVE VARIOUS CONTROLLED PARKING ZONES  
CONSOLIDATION ORDER 2008 AMENDMENT ORDER No.12 2011**

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the above named Order.

The provisions of this Order will come into operation on the ~~30<sup>th</sup>~~ <sup>3<sup>rd</sup></sup> day of ~~November~~ <sup>November</sup> 2011 and amend the Brighton & Hove Various Controlled Parking Zones Consolidation Order 2008 as follows:-

**Controlled Parking Zone C**

Add new item 53a

William Street

West side from a point 35.5 metres north of the northern kerbline of Edward Street northwards for a distance of 5.5 metres (outside County Court)

**Controlled Parking Zone H**

**Disabled Badge Holders Parking At Any Time**

Add new item 63a

Arundel Street

West side from a point 4 metres south of the southern kerbline of Eastern Road southwards for a distance of 6.6 metres (outside No.33)

**Controlled Parking Zone J**

**Disabled Badge Holders Parking At Any Time**

Delete existing item 17

Vere Road

East from a point 0.5 metres south of the northern boundary of property No.38 Vere Road northwards for a distance of 6.6 metres

**Controlled Parking Zone O**

Delete existing item 3

Caburn Road

West side from a point 42 metres north of the northern kerbline of Highdown Road northwards for a distance of 6.6 metres (outside No.8)

Delete existing item 4  
Caburn Road

East side from a point 3.5 metres north of the common boundary of Nos. 11 & 15 Caburn Road northwards for a distance of 6.6 metres (outside No.15)

Add new item 7a  
Byron Street

South side from the east boundary wall of No.70 Byron Street westwards for a distance of 6.6 metres (outside No.70)

Delete existing item 14  
Holland Road

West side from a point 19.5 metres south of the southern kerbline of Lyndhurst Road southwards for a distance of 6.6 metres (outside Lyndhurst Corner)

Add new item 87a  
Sheridan Terrace

North side from a point 6 metres east of the eastern boundary wall of No.18 Sheridan Terrace eastwards for a distance of 6 metres (outside Nos. 24/26)

**Controlled Parking Zone Y**


