BRIGHTON & HOVE VARIOUS CONTROLLED PARKING ZONES CONSOLIDATION ORDER 2008 AMENDMENT ORDER No. I 2012

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers hereby make the above named Order.

The provisions of this Order will come into operation on the 1st day of April 2012 and amend the Brighton & Hove Various Controlled Parking Zones Consolidation Order 2008 as follows:

Part 2.1 No Loading At Any Time

Add new item 7b : "East Street - West Side- From the northern kerbline of Kings Place northwards for 8 metres - Z"

Add new item 10a: "Kings Road - South Side- From the western kerbline of East Street westwards for 26 metres - Z"

Part 4.1 Permit parking only from Monday to Sunday between 9am -8pm inclusive

Add new item 10a: "Brills Lane – East Side - From a point 14.5 metres north of the northern kerbline of Grand Junction Road northwards for 10 metres – Z"

Part 6.4 Exclusive High Tariff Short Term Pay & Display parking (for a period of up to 2 hours no return within 4 hours) from Monday to Sunday between 9am and 6pm inclusive

Delete Item No.6: "East Street – From a point 7 metres north of the northern property boundary of no.15 East Street, southwards for a distance of 55 metres – Z" and substitute the following:

"West – From a point 7 metres north of the northern property boundary of no. 15 East Street, southwards to a point 27.5 metres – Z"

Delete Item No. 7: "East Street – west side- From a point 2 metres south of the southern property boundary of no. Ia East Street, southwards for a distance of 14metres - Z"

Delete existing description for Item No.10 - King's Road: "From a point adjacent to the western property boundary of no. 5 King's Road westwards for a distance of 26 metres" and substitute with the following:

"From a point 41 metres west of the western kerbline of East Street westwards for a distance of 11 metres".

Part 9.1 Disabled Badge Holders Parking At Any Time

Delete Item No.2: "Brills Lane – East - From a point 7 metres north of the northern kerb line of Grand Junction Road, northwards for a distance of 19.8metres - Z" and substitute with the following:

"East side – From a point 9.5 metres north of the northern kerbline of Grand lunction Road, northwards for a distance of 5 metres"

Part 11.1 Motorcycles Only At Any Time

Delete item No. 12: "East Street – West Side – From a point 1 metre south of the northern property boundary of no.7 East Street south-westwards for 6 metres – Z" and substitute with the following:

"West side - From a point 23 metres north of the northern kerbline of King's Road northwards for a distance of 4.5 metres - Z"

Part 12.1 Loading Only At Any Time

Delete existing description for Item No.16 - King's Road: "From a point adjacent to the western property boundary of no. 5 King's Road, eastwards for a distance of 15 metres" and substitute with the following:

"From a point 26 metres west of the western kerbline of East Street westwards for a distance of 15 metres"

Delete item No 10. "East Street – West Side – From a point 2 metres south of the property boundary of nos 6 & 7 East Street southwards for a distance of 12 metres - Z" and substitute with the following:

"West Side – From a point 8 metres north of the northern kerbline of King's Road northwards for 15 metres – Z"

Part 12.15 Loading Only Monday to Sunday 30 mins no return in 2 hours

Add new item I " East Street - East Side - From a point 4 metres south of the southern kerbline of Brills Lane southwards for 10 metres.
